##### **Letter dated 20 May 2018 from the Group of Experts on the Democratic Republic of the Congo addressed to the President of the Security Council (S/2018/531)**

**The President** (*spoke in Russian*): The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2018/643, which contains the text of a draft resolution submitted by France.

I wish to draw the attention of Council members to document S/2018/531, which contains the text of a

letter dated 20 May 2018 from the Group of Experts on the Democratic Republic of the Congo addressed to the President of the Security Council.

The Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.

**The President** (*spoke in Russian*): The draft resolution received 15 votes in favour. The draft resolution has been adopted unanimously as resolution 2424 (2018).
