
Excellency,


J O I N T   C O M M U N I Q U E

The Governments of the Czech and Slovak Federal Republic and of the Kingdom of Swaziland, desirous to develop close relations of friendship and cooperation for the mutual benefit of their peoples, and guided by the principles of international law, particularly those embodied in the Charter of the United Nations, and by the provisions of the Vienna Convention on Diplomatic Relations of 1961, have decided to establish diplomatic relations as of 4 January 1991 at ambassadorial level.


