Remarks: Griffiths was arrested in an apartment house on a charge of larceny, and during a search of his room a cigarette tin and a tobacco tin containing 34 grammes and 56 grammes, respectively, of Indian Hemp was discovered. When questioned, he at first said that "he had picked it up in the street", but later made the following statement "The stuff is hashish. It came from Bona in North Africa but I didn't buy it there. One of the boys off the ship hid it in the stokehold, and I brought it ashore."
- 16. Legal proceedings, penalties: The offender was charged with being an unauthorized person in possession of a quantity of Indian Hemp, and fined £20.0.0. (USA \$80.54) and £3.3.0. (USA \$12.68) costs.
