SEIZURE OF 18 KILOGRAMS 311 GRAMMES OF OPIUM AT BOMBAY, 9 MAY 1946

Report communicated by the Government of India 4 March 1947

Note by the Secretary-General

In accordance with Article 23 of the Convention for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs of 13 July 1931, as emended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following report on the above-mentioned seizure to the Members of the United Nations and to the other parties to the Convention.
