## SEIZURE REPORT

1. Date of seizure:

26th May 1947.

- 8. Ports of call: Left Liverpool on 4th May 1945, and was away two years Far East; ports of call on outward voyage were Port Said, Aden and Sydney. At Bombay, just prior to her departure to Britain, a new native crew was signed on. Ports of call on homeward voyage were Suez and Port Said.
- 9. Owners or nationality of ship: British.
- 10. Kind and quantity of drug seized: Prepared Opium 5 lbs. (2 kg. 267.9 gr)
  Hashish 2 lbs. (907.2 grs.)
- ll. Origin of drug. (marks, labels, etc.) Origin unknown no identifying marks or labels.

- Remarks: During a rummage by H.M. Customs Officers, four small brown paper parcels containing a total of 2 lbs. (907.2 grs) of Hashish were found in a ventilator in the seamen's lavatory, 3 lbs. (1 kg. 360.8 grs) of Opium under a coil of rope in the starboard lifeboat (aft), and a parcel containing 2 lbs. (907.2 grs) of Opium was found in the aft port lifeboat, between a buoyancy tank and the side of the boat. Every effort was made to trace the owner, but without success.
