JOINT COMMUNIQUE

CONCERNING THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF AUSTRIA AND THE REPUBLIC OF NAMIBIA

The Austrian Federal Government and the Government of the Republic of Namibia have agreed to establish bonds of friendship and cooperation on the basis of mutual respect of national sovereignty, territorial integrity, non-interference in the internal affairs of each other, and equal rights.

The Governments of both countries espress the hope that the establishment of diplomatic relations will lead to further improvement of the existing friendly relations and a mutually beneficial cooperation between the two countries.

Desiring to obtain this objective, the two Governments have decided to establish diplomatic relations effective 5 October 1990.
