We have the honour to present our compliment to you and to request your kind assistance in having the following text of the joint communique on the establishment of diplomatic relations between the Government of the Republic of Maldives and the Government of the Republic of Namibia, which is published simultaneously today by the two Governments, circulated as a United Nations document:

"The Government of the Republic of Maldives and the Government of the Republic of Namibia, guided by the principles enunciated in the Charter of the United Nations and being desirous to establish relations of friendship and mutually beneficial cooperation have decided to establish diplomatic relations between the two countries at Ambassadorial level with effect from 25 July 1990."


