
Joint Communiqué

The governments of the United Mexican States and the Democratic Republic of Sao Tome and Principe, guided by their willingness to strengthen the cooperation and understanding amongst their people, have decided to establish diplomatic relations as of this date.

Such relations will be based on the principles of the sovereign equality of nations, the mutual respect for the sovereignty, independence and territorial integrity, the non intervention in the internal affairs of others and peaceful coexistence.
