
Excellency,

on the Establishment of Diplomatic Relations between

The Republic of Hungary and the Kingdom of Swaziland,

Desiring to develop friendly relations and strengthen the co-operation between the two countries and their peoples,


Desiring further to contribute to the strengthening of international peace and security on the basis of respect of the principles of international law,

Have agreed to establish diplomatic relations at ambassadorial level with effect of the date of signature of the present Protocol.
