

COMUNICADO CONJUNTO  
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE LA  
REPUBLICA DE PANAMA Y LA REPUBLICA POPULAR DE ANGOLA.

Los Gobiernos de la República de Panamá y de la República Popular de Angola han acordado consolidar sus lazos de amistad y cooperación sobre la base de los principios de respeto mutuo de la soberanía nacional, integridad territorial, no injerencia en los asuntos internos e igualdad de derechos.

Deseando alcanzar este objetivo, los dos Gobiernos han decidido establecer relaciones diplomáticas formales a nivel de Embajadores, a partir del 16 de febrero de 1989.



JOINT COMMUNIQUE  
BETWEEN PEOPLE'S REPUBLIC OF ANGOLA AND PANAMA

THE GOVERNMENTS OF THE PEOPLE'S REPUBLIC OF ANGOLA AND PANAMA HAVE AGREED TO CONSOLIDATE BONDS OF FRIENDSHIP AND COOPERATION ON THE BASIS OF THE PRINCIPLES OF MUTUAL RESPECT OF NATIONAL SOVEREIGNTY, TERRITORIAL INTEGRITY, NON-INTERFERENCE IN THE INTERNAL AFFAIRS OF EACH OTHER, AND EQUAL RIGHTS.

DESIRING TO OBTAIN THIS OBJECTIVE, THE TWO GOVERNMENTS HAVE DECIDED TO ESTABLISH FORMAL DIPLOMATIC RELATIONS AT AMBASSADORIAL LEVEL, WITH EFFECT FROM FEBRUARY 16, 1989.

THE GOVERNMENTS OF BOTH COUNTRIES EXPRESS THE HOPE THAT THE ESTABLISHMENT OF DIPLOMATIC RELATIONS WILL LEAD TO THE DEVELOPMENT OF MUTUALLY BENEFICIAL COOPERATION.
