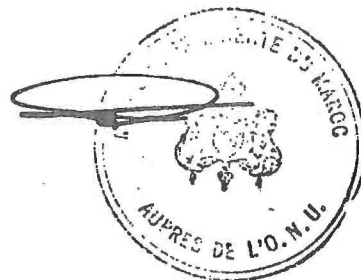

JOINT COMMUNIQUE

The Government of the Democratic People's Republic of Korea and the Government of the Kingdom of Morocco, desirous of promoting relations of friendship and economic and cultural co-operation between their two countries on the basis of respect of the purposes and principles of the United Nations Charter, have decided to establish diplomatic relations at the level of Ambassadors Extraordinary and Plenipotentiary as of February 13, 1989.

Both Governments express the hope that such decision will contribute to enhancing a mutually beneficial co-operation between the two countries.
