### Dissemination of information on the United Nations and the International Trusteeship System: report of the Secretary-General

#### INTRODUCTION

1. By Trusteeship Council resolution 36 (III) of 8 July 1948 and General Assembly resolution 754 (VIII) of 9 December 1953, the Secretary-General and the Administering Authorities concerned were requested to co-operate in ensuring an adequate flow of suitable information, including records of the Trusteeship Council and material concerning the aims and activities of the United Nations, to the general public in the Trust Territories, and to inform the Council periodically of the action taken. The present report covers the period from 1 June 1972 to 13 April 1973.

#### DISTRIBUTION OF OFFICIAL RECORDS

2. During the period under review, the distribution of official records<sup>1</sup> by the United Nations to addresses supplied by the Administering Authorities was as follows:

#### DISSEMINATION OF INFORMATION IN THE TRUST TERRITORIES

##### *General*

3. During the period under review, the work of disseminating information on the United Nations was actively pursued in the Trust Territory of the Pacific Islands and in Papua New Guinea. These activities were conducted through the United Nations information centres in Washington, D.C. and in Port Moresby.

4. The services of those centres to the media, including the press and radio, were expanded to meet the increased interest in the United Nations and the International Trusteeship System within the Territories. Efforts were made in both Territories to strengthen the relationship between the centres and government authorities, educational institutions and non-governmental organizations. A greater flow of information material was established and maintained between the centres and the major information channels.

#### *Trust Territory of the Pacific Islands*

5. In addition to the close contact maintained with the United States Department of the Interior, the United Nations Information Centre in Washington, D.C., opened new lines of communications with other government agencies for the purpose of compiling a comprehensive, up-to-date working list of organizations interested in the activities of the United Nations in the Trust Territory.

6. The district legislatures of the Mariana Islands, Palau, the Marshall Islands and Ponape were added to the distribution list of the Centre, as well as a number of offices of the Congress of Micronesia. Public awareness of United Nations activities was reflected in resolutions passed by legislative bodies on problems of economic development, the need for technical assistance, decolonization, the admission of the Trust Territory to the United Nations Economic Commission for Asia and the Far East (ECAFE), requests for United Nations volunteers and disarmament.

7. Information kits on decolonization, economic and social development and disarmament were sent to the offices of the district administrators. These offices have provided the names of libraries in the districts for the Centre's mailing list.

8. The Centre contacted educational institutions in the Territory, including 169 elementary schools, 6 secondary schools and the Community College of Micronesia. Many schools requested additional copies of the publications entitled *The United Nations and What You Should Know about It* and *Basic Facts about the United Nations* for use as textbooks in the class-room.

9. The flow of United Nations information to the press and to radio stations in the Territory has been increased in the last 12 months. Selected pamphlets were sent to *The Micronitor*, *The Senyavin Times* and *Met Poraus*, which are published in the Territory. Information kits were also sent to *Highlights*, a bi-monthly newsletter published by the Office of the High Commissioner, the *Micronesian Reporter*, a quarterly journal of the Territory, and to the Micronesian News Service.

10. The Centre distributed background material to radio stations in all districts. Stations WSZD and WSZC, in the Eastern Carolines, made use of "Scope", "Perspective" and "This Week at the United Nations". Summaries were broadcast in local languages. Radio stations WSZA and WSZB, in the Western Carolines, and WSZO, in the Marshall Islands, made use of the

same material. No details are available on how the material was used by station KJZR, in the Mariana Islands.

### *Papua New Guinea*

11. During the year under review, the United Nations Information Centre in Port Moresby continued to assist the Administration, educational institutions, the media and non-governmental organizations. Special efforts were made to provide as much material as possible to the House of Assembly and to the Government of Papua New Guinea. Requests for information continued to be received from the House of Assembly, the office of the Chief Minister and the office of the Leader of the Opposition. The Centre maintained a mailing list of 602 addresses.

12. The Administering Authority continued to provide financial assistance to the Centre, including the rental of the premises, internal postage, general services and transportation for official business. It helped the Centre to find more centrally located office premises in Port Moresby. The Administration's grant was increased by \$A2,460 to \$A12,460 to cover the rent for the new premises.

13. The Centre produced and distributed the following: (a) *Wall Sheets on the United Nations*, 2,000 copies of five wall sheets illustrating the work of the

United Nations in English, Pidgin and Motu; (b) *Pidgin Basic Facts*, 1,000 copies of a simplified Pidgin version of *Basic Facts*. The following publications, produced locally, were also distributed: (a) *Eleven Hundred Million*, a simple booklet on decolonization; (b) *Sacred Trust*, the Trusteeship Agreement for the Territory of New Guinea and General Assembly recommendations on Papua New Guinea; (c) *Trusteeship Council*, a summary of its conclusions and recommendations; (d) *Basic Facts*, on the United Nations and Papua New Guinea, a simplified English-language version of *Basic Facts*.

14. In 1972, the Centre issued 115 features and press releases, 46 weekly newsletters and 33 Pidgin summary newsletters and lent 1,484 films. During the first quarter of 1973, the Centre issued 6 feature releases, 6 fortnightly newsletters and 5 Pidgin newsletters, in addition to 33 press releases. The Director and the Information Assistant gave 29 lectures during the period under review.

15. The Centre made available United Nations radio programmes, including "Scope", "Perspective", and "This Week at the United Nations", as well as programmes for United Nations Day, Human Rights Day and International Day for the Elimination of Racial Discrimination.

### **Offers by Member States of study and training facilities for inhabitants of Trust Territories: report of the Secretary-General**

[Original: English]  
[18 June 1973]

1. By resolutions 557 (VI) of 18 January 1952 and 753 (VIII) of 9 December 1953, the General Assembly invited Member States to make available to qualified students from Trust Territories scholarships, fellowships and internships for university study and post-primary and technical education.

2. The programme is administered in accordance with the procedure approved by the Trusteeship Council at its thirteenth session.<sup>2</sup> Under this procedure, the Secretary-General was invited to submit to the Trusteeship Council at least once a year a report containing all appropriate details of the programme. The present report is the twenty-second such report and covers the period from 1 June 1972 to 31 May 1973.

3. As stated in previous reports, 11 Member States had in the past made scholarships available under this programme. Those Member States were the following: Czechoslovakia, Hungary, Indonesia, Italy, Mexico, Pakistan, Philippines, Poland, Tunisia, Union of Soviet Socialist Republics and Yugoslavia.

4. A description of the scholarships offered by Member States is contained in the eighteenth report

submitted to the Trusteeship Council at its thirty-sixth session.<sup>3</sup>

5. Up-to-date information concerning the scholarships made available under the programme, as well as the extent to which awards had been made to, and utilized by, students from Papua New Guinea and the Trust Territory of the Pacific Islands, was requested by the Secretary-General in a note dated 30 March 1973, addressed to the Member States that had offered scholarships in previous years.

6. In a note dated 15 June 1973, the Permanent Mission of the Union of Soviet Socialist Republics informed the Secretary-General that, at present, no inhabitants from the Trust Territories were studying in the Soviet Union.

7. Information on the scholarships made available under the programme is included in the handbook *Study Abroad*, nineteenth edition, 1972/73-1973/74, published by the United Nations Educational, Scientific and Cultural Organization (UNESCO). Copies of *Study Abroad* are sent to the Administering Authorities and to United Nations information centres.

**Report of the Drafting Committee on Papua New Guinea**

1. At its 1411th meeting, held on 6 June 1973, the Trusteeship Council appointed a drafting committee composed of the representatives of the United Kingdom of Great Britain and Northern Ireland and the United States of America to propose, on the basis of discussions which had taken place in the Council, conclusions and recommendations on conditions in Papua New Guinea and to make recommendations concerning the chapter on conditions in that Territory for inclusion in the next report of the Trusteeship Council to the General Assembly.

2. The Drafting Committee held three meetings. It had the benefit of the assistance of the representatives of the Administering Authority.

3. In the light of the general discussions in the Council on conditions in the Territory, the Committee drafted a number of conclusions and recommendations which it considered as reflecting the opinion of the

majority of the members of the Council and which are set forth in the annex to the present report.

4. The Committee recommends that the Trusteeship Council adopt the revised working paper on conditions in Papua New Guinea (T/L.1179 and Add.1 and 2) as the basic text for the chapter on conditions in that Territory to be included in the next report of the Trusteeship Council to the General Assembly.

5. The Committee also recommends that the Trusteeship Council adopt the conclusions and recommendations set out in the annex below and include them at the end of each appropriate section or subsection of the chapter.

**Report of the Drafting Committee on the Trust Territory of the Pacific Islands**

1. At its 1417th meeting, held on 15 June 1973, the Trusteeship Council appointed a drafting committee composed of the representatives of Australia and France to propose, on the basis of the discussions which had taken place in the Council, conclusions and recommendations on conditions in the Trust Territory of the Pacific Islands, and to make recommendations concerning the chapter on conditions in that Territory for inclusion in the next report of the Trusteeship Council to the Security Council.

2. The Drafting Committee held three meetings. It had the benefit of the assistance of a representative of the Administering Authority.

3. In the light of the general discussions in the Council on conditions in the Territory, the Committee drafted a number of conclusions and recommendations which it considered as reflecting the opinions of the majority of the members of the Council and which are set forth in the annex to the present report.

4. The Committee recommends to the Trusteeship Council that it adopt the revised working paper on conditions in the Trust Territory of the Pacific Islands (T/L.1178 and Add.1) as the basic text for the chapter on conditions in that Territory to be included in the next report of the Trusteeship Council to the Security Council.

5. The Committee also recommends that the Trusteeship Council adopt the conclusions and recommendations set out in the annex and include them at the end of each appropriate section or subsection of the chapter.
