> SUBSISTENCE ALLOWANCE RATES FOR COMPUTING INSTALLATION GRANTS

#### 1. Revised travel subsistence allowance rate:

In accordance with Staff Rule 107.15 (a), the Secretary-General has established a revised schedule of travel subsistence rates, as shown in Annex A, effective 1 July 1958. This revised schedule will supersede the existing schedule announced in ST/AI/96/Amend. 10.

As hitherto, the rates of subsistence allowance applicable in each country are shown by means of group numbers, but the rates applicable to staff members in the various salary levels under each group have been revised as indicated below:

Where a special minimum rate has been indicated against a group number in the schedule, the appropriate group rate or the special minimum rate, whichever is higher, will apply.

Group 2 rates will apply for all areas not otherwise designated in the schedule.

# Special travel subsistence allowance rates for staff members detailed to Geneva for extended periods of duty

Pursuant to Staff Rule 107.16 and in place of ST/AI/96/Amend.11, the Secretary-General has decided that effective <u>1</u> July 1958, all staff members while in travel status in Geneva for Conferences or other extended periods of duty shall recieve travel subsistence allowance as follows:

- (i) At the rates established under Staff Rule 107.15 (a), during the first thirty days in travel status;
- (ii) At the special rates equivalent to 80 per cent of the rates mentioned in (i) above, after the first thirty days in travel status.

The Secretary-General has also decided that under this arrangement the reduction of \$3.00 per day after sixty days contemplated in Staff Rule 107.17 will not be applied.

This instruction does not apply to staff engaged under short-term appointments for Conferences or other short-term service.

3. Special subsistence allowance rates for computing installation grants ided by lo7.20 6, Amd 12 Pursuant to Staff Rule 107.17 (c) (i), the Secretary-General has established 1 a schedule of special subsistence allowance rates. This schedule, which appears 8 in annex B, will be effective 1 July 1958.

The rates prescribed in annex B will be used in place of the normal rates in annex A for computing installation grant payments for eligible staff members in the General Service category at the main duty stations.
