Introductory Note

- 1. The UNDEX List of Documents Issued, prepared by the Documentation Services Division of the Dag Hammarskjold Library at United Nations Headquarters, contains a listing and the bibliographical description of all documents and publications of the United Nations received by the Library, except restricted material and internal papers, and all printed publications of the International Court of Justice.
- 2. The list is compiled by conventional methods and is issued ten times a year in two language versions, English and French. The coverage of each issue is limited to specific series of documents and follows an established yearly pattern as follows:
 - <u>Issues 1 and 6:</u> documents issued in the General Assembly series (A/- symbols)
 - <u>Issues 2 and 7:</u> documents issued in the Economic and Social Council series (E/- symbols)
 - Issues 3 and 8: documents issued in the Security

 Council series (S/- symbols), the Trusteeship

 Council series (T/- symbols), publications of the

 International Court of Justice, and sales publications
 - Issues 4 and 9: documents issued in the Secretariat series (ST/- symbols) and in the series of the regional economic commissions (E/CN.11/-, E/CN.12/-, E/CN.14/-, E/ECE/- and E/CN.15/- symbols)
 - Issues 5 and 10: documents issued in all other series (UNCTAD, UNIDO, UNICEF, UNDP, etc.). Issue No.10 also contains a consolidated list of periodicals.
- 3. The material is entered according to series symbols. Publications that do not bear a symbol are entered by title under the issuing body. An asterisk (*) is used to indicate documents issued as drafts or preliminary texts subject to revision, or issued in provisional (mimeographed) editions subject to later publication in printed Official Records or as printed sales publications. A square () appearing next to a series or to an entry denotes that the documents in the series or the document described in the entry are analysed and the annotations relating to them are stored in computer files. Also, it indicates that the full texts of the documents are available in microfiche form. Information concerning the different language versions of documents is given at the beginning of each series.
- 4. The full text of documents listed is preserved in the documentary collections of the Library in the original hard copy and on microfiche or microfilm. Staff of permanent missions and delegations and of the Secretariat and other qualified users may consult the documents in room L-260 (telephone extensions 2501, 2502, 2504). Reference staff is on duty to assist users in locating the information needed. Photocopies are available on request upon payment of a fee.

Other indexes prepared by the Documentation Services Division

- 5. Subject guides to the information contained in United Nations documents and publications are available in the following separate series:
- (a) The UNDEX Subject Index (ST/LIB/SER.I/A.-) provides a subject approach to the most relevant information contained in United Nations documentation and also provides, in a standardized form, keys for access to computer files or other computer-based tools that may contain additional information;
- (b) The UNDEX Country Index (ST/LIB/SER.I/B.-) provides information on the major aspects of the participation of Member States in United Nations affairs and reference to the documents containing a record of it;
- (c) The Index to Proceedings series (ST/LIB/SER.B/A.-, ST/LIB/SER.B/E.-, ST/LIB/SER.B/S.-, ST/LIB/SER.B/T.-) provides a bibliographical guide to the proceedings and related documentation of sessions of the General Assembly, the Security Council, the Economic and Social Council and the Trusteeship Council;
- (d) The Index to Resolutions series (ST/LIB/SER.H/-) provides a cumulative guide to the information contained in resolutions adopted by United Nations organs and bodies; and
- (e) Cumulative indexes to the United Nations *Treaty Series* provide a guide to the treaties and international agreements registered or filed and recorded with the Secretariat of the United Nations.
- 6. The indexes listed in paragraph 5 (a) and (b) are issued in four language versions: English, French, Spanish and Russian; those listed in (c) and (d) are issued in English only. The cumulative indexes to the United Nations Treaty Series are issued in English and French. Additional information concerning these indexes is contained in the booklet UNDIS: A Handbook of Products and Services (ST/LIB/33).

Symbols of United Nations documents

7. Symbols of United Nations documents are made up of juxtaposed elements that indicate the authority under which they are issued. These elements, which are separated by oblique strokes, are composed of capital letters and figures, usually Arabic numerals. When Roman numerals are used they usually indicate the number of the session or the number of the subsidiary organs (e.g., -/WG.II/-). Documents of two or more organs may carry two or more symbols, one for each organ. If a document is reissued in the printed Official Records or as a sales publication, it retains its symbol. A sales publication normally carries both a symbol and a sales code.

15. Additional information concerning United Nations document series symbols, as well as a broad subject guide to the series, can be found in the publication *List of United Nations Document Series Symbols* (ST/LIB/SER.B/5/Rev.2). *

Categories of distribution of documents and meeting records

- 16. For distribution purposes, documents and meeting records are classified in the following categories, each indicating the pattern and scope of distribution: (a) GEN-ERAL; (b) LIMITED, and (c) RESTRICTED.
- (a) The designation GENERAL is used on basic documents and final meeting records, including agendas, studies and reports previously requested, communications from Governments and adopted resolutions and other decisions of main organs. Documents in this category are given the widest distribution appropriate to the body concerned. The texts of documents issued in the GENERAL series are not included in, or annexed to, subsequent documents, as they are easily accessible to all interested parties.
- (b) The designation LIMITED is used on documents of a temporary nature such as draft resolutions and amendments thereto, draft reports and other action documents, and papers dealing with the order in which items will be discussed and other ephemeral matters. The primary distribution of documents in this category is limited to those likely to be immediately interested in the work of the body concerned. The substance of limited documents may, as appropriate and reasonable, be referred to or included in, or annexed to, the report of the body in which they were discussed. Limited documents bear the letter "L" before the serial number.
- (c) The designation RESTRICTED is used on documents and meeting records whose contents require at the time of issuance that they not be made public. The distribution of these documents and records is determined by the originating office. Such documents bear the letter "R" before the serial number in the symbol.
- 17. The principles governing the classification and declassification of documents by the Secretariat have been set forth in document ST/AI/189/Add.16.

18. Provisional texts of documents and meeting records are issued first in a limited run; such documents comprise unrevised translations circulated in the course of a meeting and certain meeting records that will later be issued in corrected form. They bear the word PROVISIONAL above the document symbol. In bodies with limited membership, provisional documents may also bear the instruction FOR PARTICIPANTS ONLY.

Availability of United Nations material

Free distribution

19. Documents and publications are distributed free of charge to Member States, specialized agencies, non-governmental organizations in consultative status, and depository libraries, under agreed arrangements. It should be noted that documents published by the regional economic commissions of the United Nations cannot be distributed to depository libraries as quickly as those originating at Headquarters. Documents of the subsidiary organs of the Economic Commission for Africa, the Economic Commission for Asia and the Far East, the Economic Commission for Latin America and the Economic Commission for Western Asia are not distributed to depository libraries outside the respective regions and are not available upon request, except in special circumstances. Documents of missions in the field are not available for distribution.

Depository libraries

- 20. A network of depository libraries has been established by the United Nations, so that throughout the world there are reference collections of United Nations documents accessible to the public. A consolidated list of libraries and information centres receiving United Nations material is contained in documents ST/LIB/12/Rev.5 and Add.1 and 2.
- 21. The principles governing the depository libraries system are contained in documents ST/AI/189/Add.11 and Amend 1.
- 22. All depository and parliamentary libraries open to the public receive automatically, according to their needs, all publications offered for sale, including Official Records, and public information material distributed free, as available in the official language of their choice.
- 23. Depository and parliamentary libraries that are able to handle a larger volume of material receive in addition all other generally distributed documents and publications of the United Nations, whether reproduced by printing or other processes, as available in the official language of their choice.
- 24. Policies concerning the distribution of documents and publications to depository libraries are set forth in documents ST/LIB/13/Rev.2.

The Official Records of the main organs of the United Nations and the United Nations Treaty Series are at present available on microfiche. Additional series of microfiches are expected to be offered on sale in the future as more material in this form becomes available.
- 28. Sets of United Nations documents from 1947 up to 1968 are available on microfilm. Indexes to microfilms have been issued in English (1946-1961, 1962-1967), and French, Russian and Spanish (1946-1952) and are available on request from the Library at United Nations Headquarters.
