Introductory Note

- 1. This index contains information on the major aspects of the participation of Member States in United Nations affairs and references to the documents containing a record of it. Each issue covers material received for analysis in the period consisting of the first three weeks of the month indicated on the cover and the last part of the preceding month, with the exception of the September issue, which covers material received from the last part of June through the first part of September. The index is not issued in July and August.
- 2. The information provided is that considered sufficient to locate the documents containing specific data on aspects of the participation of Member States in United Nations affairs. It has been selected, extracted and compiled mechanically in four languages (English, French, Russian and Spanish) from annotations prepared in English only and stored in a computer together with quadrilingual lists of terms used in the preparation of the annotations.
- 3. The information stored in computer-based files consists of:
- (a) Data required for the identification of the document: symbol(s), microfiche number, job number, sales number, symbol of document in which the text is republished:
- (b) Bibliographical information: author, title of publication, title of article in a periodical, date of issue, place of issue, number of pages, price, series title etc.;
- (c) Information on original language and on language versions available;
 - (d) Information on distribution category:
- (e) Analytical statements, in formalized form, on subjects about which information is contained in the document:
- (f) Summaries, in narrative form, of the contents of studies, reports and proceedings of conferences and of the recommendations they contain;
- (g) Verbatim texts of operative paragraphs of resolutions adopted by the General Assembly and the three Councils;
- (h) Brief annotations on the contents of documents other than studies, reports or records of meetings;
 - (i) Analytical information on roll-call votes;
- (j) Information on statements in debates (including names of speakers);
- (k) Information on membership of organs and subsidiary organs;
- (1) References to action taken on texts, such as discussion of documents in meetings; adoption of draft resolutions; results of voting; amendments submitted etc.;

- (m) Data required for selective retrieval and refinement of searches:
 - (i) Names of countries:
 - (ii) Type of document;
 - (iii) Type of action;
 - (iv) Date of action;
 - (v) Name of organ, session, agenda item number;
- (n) Quadrilingual terms (English, French, Russian and Spanish) used in indexing documents:
 - (i) Subject terms;
 - (ii) Geographical names;
 - (iii) Personal names;
 - (iv) Titles of publications;
 - (v) Names of organs;
- (o) Classification of terms according to type and field of activity.
- 4. At present, the computer-based files from which the UNDEX Country Index is produced contain analytical information extracted from, or relating to, the following documents and publications issued from 1969 on, unless otherwise indicated:
- (a) Resolutions, reports, verbatim records and other documents issued for the plenary meetings of the General Assembly;
- (b) Resolutions, reports and verbatim records of the Security Council;
- (c) Resolutions, reports, summary records and other documents of the Economic and Social Council, its standing and sessional committees and its functional commissions:
- (d) Resolutions, reports and summary records of the Trusteeship Council;
- (e) Resolutions, annual and sessional reports and printed publications of the regional economic commissions;
- (f) Sessional reports and printed publications of the United Nations Conference on Trade and Development (UNCTAD) and the United Nations Industrial Development Organization (UNIDO);
- (g) Sessional reports of the Governing Council of the United Nations Development Programme (UNDP) and the Executive Board of the United Nations Children's Fund (UNICEF), annual reports of the Executive Director of the United Nations Institute for Training and Research (UNITAR) and of the United Nations High Commissioner for Refugees (UNHCR);

- (h) Reports, meeting records and other documents of the International Law Commission and the United Nations Commission on International Trade Law (UNCITRAL):
- (i) Documents of the Committee on the Peaceful Uses of Outer Space and the Committee on the Peaceful Uses of the Sea-Bed and the Ocean Floor beyond the Limits of National Jurisdiction:
- (j) Proceedings of major United Nations conferences;
- (k) Publications of the International Court of Justice:
- (1) Analytical summaries of annual reports submitted to the Economic and Social Council by the specialized agencies and to the General Assembly by the International Atomic Energy Agency (IAEA);
- (m) Studies and reports issued as sales publications from 1972 on;
- (n) Articles included in United Nations periodicals from 1972 on.
- 5. No analytical information has been stored in computerbased files with respect to the following:
- (a) Mimeographed documentation of the regional economic commissions, UNCTAD, UNIDO, UNICEF, UNDP, UNITAR, or UNHCR. (Some regional economic commissions, UNCTAD, UNIDO and UNICEF publish their own indexes).
- (b) Documentation of the Main Committees of the General Assembly and ad hoc committees and other subsidiary bodies, the reports of which appear either in the series of the parent organs or in printed form as sales publications. However, references to these documents contained in documents issued in the series analysed for storage are included in the computer-based files. Also, all documentation issued in connexion with the proceedings of the General Assembly and the three Councils is indexed comprehensively in the *Index to Proceedings* series.
- (c) Volumes of the United Nations Treaty Series. Chronological, subject and country indexes to the contents of the Treaty Series are prepared by conventional methods and published in English and French. (Computerization of the treaty registration files is under consideration in the Office of Legal Affairs, pursuant to a decision of the General Assembly.)
- 6. Each page of the UNDEX Country Index contains entries displayed in four vertical columns, each entry consisting of four elements:

Name of country;

- Code words, describing the type of participation or action;
- Subject statement, describing concisely the question to which the action relates;
- Symbol of the document in which the information is contained.

- 7. The name of country appearing in the first column is given in the current official short form. In a few instances, the form of the entry has been slightly modified to facilitate processing by computer.
- 8. The code words appearing in the second column are used to describe the type of action and bring together references to documents containing information of the same type. The code words used at present are:
 - ASPECTS. Under this term are brought together references to information about a country, such as United Nations activity in the country, admission to membership in the United Nations, implementation of human rights, economic and social conditions.
 - DOCUMENTS SUBMITTED. This term is used to bring together references to communications, proposals, draft resolutions, comments, etc. submitted by the country.
 - MEMBERSHIP. Information on the representation of a country in the various United Nations organs is grouped under this term. Variant terms are:
 - MEMBERSHIP (PERS), indicating that representation of that country is by a person appointed in an individual capacity;
 - MEMBERSHIP (WITH), indicating withdrawal from membership.
 - STATEMENTS IN DEBATES. Under this term are brought together statements made by representatives during the discussion of questions before United Nations organs. Variant terms are:
 - STATEMENTS IN DEBATES (EXPL), indicating statements made in explanation of a vote;
 - STATEMENTS IN DEBATES (REPL), indicating statements made in the exercise of the right of reply.
 - TREATIES. The term is used, in conjunction with other code words, to bring together references to the action taken by countries with respect to treaties. The four variants in use are:
 - TREATIES: BILAT(S), indicating signature of bilateral agreements;
 - TREATIES: MULT(A), indicating accession to, or acceptance of, multilateral agreements or conventions:
 - TREATIES: MULT(R), indicating ratification of multilateral agreements or conventions;
 - TREATIES: MULT(S), indicating signature of multilateral agreements or conventions.
 - VOTING. The term is used to bring together information relating to votes cast during roll-call votes. The four variants are:
 - VOTING: ABST, indicating abstention;
 - VOTING: NO, indicating negative vote;
 - VOTING: NOT PAR, indicating absence or nonparticipation;
 - VOTING: YES, indicating an affirmative vote.

- 9. The subject statement appearing in the third column consists of a group of words separated by punctuation marks. Some of the words are in capital letters, others in lower case. The leading words in capital letters describe the main theme of the item covered by the entry. The words in lower case describe more detailed aspects. The wording of the subject statement is the same as that of the subject entries in the UNDEX Subject Index (ST/LIB/SER.I/A.-), which contains references to additional documents containing information on the subject.
- 10. The document symbol appears in the fourth column and consists of two or more elements separated by oblique strokes. The leading element indicates the organ; the following ones indicate the subsidiary organ and/or the nature of the document, the distribution category, successive modifications to the original text, as appropriate (e.g., S/10868; E/RES/1639; A/AC.121/L.15/Add.3). Additional information on symbols is contained in List of United Nations Document Series Symbols (ST/LIB/SER.B/5/Rev.2).
- 11. Ditto marks indicate that parts of an entry are the same as those appearing in the same position in the preceding entry.
- 12. The bibliographical description of the documents to which reference is made in this index is contained in UNDEX List of Documents Issued (ST/LIB/SER.I/C.-).
- 13. The full text of the documents to which reference is made in this index is preserved in the documentary collections of the United Nations Headquarters Library

- in the original hard copy and on microfiche. Staff of permanent missions and delegations and of the Secretariat and other qualified users may consult the documents in room L-260 (telephone extension 2501). Reference staff is on duty to assist users in locating the information needed. Copies of microfiches, or photographic enlargements of portions of the text which they contain, can be made available, on request, upon payment of a fee.
- 14. Additional information on the products and services available from the United Nations Documentation Information System (UNDIS) is contained in a booklet UNDIS: A Handbook of Products and Services (ST/LIB/33). Further information on UNDIS may be obtained from the Chief of the Documentation Services Division (room L-327, telephone extension 2096).
- 15. The UNDEX Country Index is published 10 times a year in English, French, Russian and Spanish and is available through official distribution. The English version is also available for sale by subscription. Subscriptions may be placed with a sales agent of United Nations publications.
