# Introductory Note

1. The UNDEX List of Documents Issued, prepared by the Dag Hammarskjöld Library at United Nations Headquarters, contains a listing and the bibliographic description of all documents and publications of the United Nations received by the Library, except restricted material and internal papers. It also includes all printed publications of the International Court of Justice.

2. Each issue covers documents and publications issued and received in the Library during the six month period prior to the month indicated on the cover. The coverage of each issue is limited to specific series of documents and follows an established yearly pattern as follows:

Issues 1 and 6: documents issued in the General Assembly series (A/- symbols)

Issues 2 and 7: documents issued in the Economic and Social Council series (E/- symbols)

Issues 3 and 8: documents issued in the Security Council series (S/- symbols), the Trusteeship Council series (T/- symbols), publications of the International Court of Justice, and sales publications

Issues 4 and 9: documents issued in the Secretariat series (ST/- symbols) and in the series of the regional economic commissions (E/CEPAL/- (E/CN.12/-), E/ECA/- (E/CN.14/-), E/ECE/-, E/ECWA/- and E/ESCAP/- (E/CN.11/-) symbols)

Issues 5 and 10: documents issued by other organs or bodies (UNCTAD, UNIDO, UNICEF, UNDP, Disarmament Commission, etc.). Issue No.10 also contains a consolidated list of periodicals.

3. The material is entered according to series symbols. Publications that do not bear a symbol are entered by title under the issuing body. An asterisk (\*) is used to indicate documents issued as drafts of preliminary texts subject to revision, or issued in provisional (mimeographed) editions subject to later publication in printed Official Records or as printed sales publications. A square (■) appearing next to a series or to an entry denotes that the documents in the series or the document described in the entry are included in UNDEX, series A and B. Also it indicates that full texts of the documents are available in microfiche form. Information concerning the different language versions of documents is given at the beginning of each series.

4. Symbols of United Nations documents are made up of juxtaposed elements that indicate the authority under which they are issued. These elements, which are separated by oblique strokes, are composed of capital letters and figures, usually Arabic numerals. Additional information concerning United Nations document series symbols, as well as a broad subject guide to the series, can be found in the publication List of United Nations Document Series Symbols (ST/LIB/SER.B/5/Rev.2). 1/

5. The UNDEX List of Documents Issued is published 10 times a year (once a month, except July and August) in English and French.

6. Other indexes prepared by the Dag Hammarskjöld Library are available in the following series:

(a) The UNDEX Subject Index (ST/LIB/SER.I/A.-) provides a subject approach to the most relevant information contained in United Nations documentation. Issued in English, French, Russian and Spanish;

(b) The UNDEX Country Index (ST/LIB/SER.I/B.-) provides information on the major aspects of the participation of Member States in United Nations affairs and reference to the documents containing a record of it. Issued in English, French, Russian and Spanish;

(c) The Index to Proceedings series (ST/LIB/SER.B/A.-, ST/LIB/SER.B/E.-, ST/LIB/SER.B/S.-, ST/LIB/SER.B/T.-) provides a bibliographic guide to the proceedings and related documentation of sessions of the General Assembly, the Security Council, the Economic and Social Council and the Trusteeship Council. Issued in English only;

(d) The Index to Resolutions series (ST/LIB/SER.H/-) provides a cumulative guide to the information contained in resolutions adopted by United Nations organs and bodies. Issued in English only;

(e) Cumulative indexes to the United Nations Treaty Series provide a guide to the treaties and international agreements registered or filed and recorded with the Secretariat of the United Nations. Issued in English and French; and

(f) The Subject Index to Selected United Nations Documents (ST/LIB/SER.J/-) provides a subject approach to the documentation issued in Chinese. Issued in Chinese only.

7. Additional information on the products and services available from the United Nations Documentation Information System (UNDIS) is contained in a booklet entitled UNDIS: A Handbook of Products and Services (ST/LIB/33). General information on United Nations documentation is contained in a booklet entitled United Nations Documentation: A Brief Guide for Official Recipients (ST/LIB/34).

8. The UNDEX List of Documents Issued is available through official distribution and for sale by subscription. Subscriptions may be placed with a sales agent of United Nations Publications. Orders and enquiries from countries without a sales agent may be addressed to United Nations Publications, room LX-2300, New York, N.Y. 10017, USA; or to United Nations Publications, Palais des Nations, 1211 Geneva 10, Switzerland.

Users may consult the documents in room L-260 (telephone extension 2501). Reference staff is on duty to assist users in locating the information needed. Photocopies of documents and copies of microfiches, or photographic enlargements of portions of the text which they contain, can be made available, on request, upon payment of a fee.

10. Documents and publications are available throughout the world in a special network of depositary libraries

established by the United Nations. The principles and policies governing the depositary libraries system are contained in document ST/LIB/13/Rev.2. A list of the depositary libraries and information centres receiving United Nations material is contained in document ST/LIB/12/Rev.5 and Add.1 and 2.

# INTERNATIONAL COURT OF JUSTICE

## PUBLICATIONS

1. The publications of the Court include:

The decisions given by the Court, consisting of judgments, advisory opinions and orders. Each decision is printed in a separate unbound edition. It is also possible to obtain, in January of each year, the collected reports for the preceding year in one bound volume (consecutive pagination is used through the year). For the benefit of those who obtain the reports at the time of their publication, a stiff cover may be purchased in which it is possible to assemble the separate reports and the index, which may also be purchased separately. The series in which these decisions are published is entitled Reports of judgments, advisory opinions and orders. This series is bilingual, English and French on facing pages.

The documentation of each case: pleadings, oral arguments, and other relevant documents. This publication appears after the Court has given its final decision in a case. The series is entitled Pleadings, oral arguments, documents. Documents, speeches of counsel, etc. are printed only in the language, English or French, in which they were submitted to the Court. Introductory material is bilingual, English and French.

Acts and documents concerning the organization of the Court. Only one volume has appeared, containing the English and French texts of the Charter of the United Nations, the Statute of the Court and the Rules of the Court, together with certain other documents. Bilingual, English and French on facing pages.

Yearbook. A yearbook appears in the autumn of each year, covering the period from August 1st of the previous year to July 31st of the current year. It contains information concerning the Court's basic texts, the organization of the Court and its composition (with biographies of the Judges), the Court's jurisdiction in contentious and advisory proceedings, the work of the Court during the year, the administration of the Court, the work of the Registry and the finances of the Court. The texts of declarations recognizing as compulsory the jurisdiction of the Court are reproduced in full, and other instruments governing the Court's jurisdiction are listed. Judgments or advisory opinions given during the course of the year are summarized. This series is published in two editions, the Yearbook in English and the Annuaire in French.

Bibliography. A bibliography is published at the beginning of each year listing all works and documents relating to the Court which have come to the Registry's attention during the previous year. Bibliographies Nos. 1-18 formed Chapter IX in the appropriate Yearbook or Annuaire up to the 1963-1964 editions, but Nos. 19 and onwards constitute a separate series of publications. Entries are in the original language of the title of the work or document listed; explanatory matter and indexes (cumulative from No. 19 onwards) are now in both English and French in the same volume.

Catalogue of Publications, in two editions, English and French. The last catalogue was published in 1967; an addendum appears each year.

## DISTRIBUTION AND SALE OF PUBLICATIONS

2. The above publications, which are edited by the Registry, are made available by the Registrar to all States entitled to appear before the Court and to international organizations. They may also be purchased by the public from bookstores and distributors throughout the world in the same way as United Nations publications. Enquiries concerning the sale of the Court's publications should be addressed not to the Registry of the Court but to the United Nations, Sales Section, New York, N.Y.10017, or to the Distribution and Sales Section, 1211 Geneva 10, Switzerland.
