JOINT COMMUNIQUE

The Government of the Republic of Bolivia and the Government of the Kingdom of Nepal, desirous of strengthening the ties of friendship and cooperation between the two countries and peoples, have agreed to establish diplomatic relations as of this date.

The Governments of both countries are convinced that the establishment of diplomatic relations based on the purposes and principles of the Charter of the United Nations will further enhance, understanding and cooperation between the two countries and peoples.


