


JOINT COMMUNIQUE

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN THE REPUBLIC OF SEYCHELLES  
AND THE REPUBLIC OF NICARAGUA

With a view to strengthening existing friendly relations and promoting cooperation between their respective countries and peoples sovereignty, non-interference in each other's internal affairs, equality and reciprocal advantage, the Government of the Republic of Seychelles and the Government of the Republic of Nicaragua have decided to establish diplomatic relations at the Ambassadorial level. Accordingly, their Joint Communique was signed today in New York by the Permanent Representatives of the two fraternal states to the United Nations.
