


We have the honour to inform you that on 28 March 1984, the Sultanate of Oman and the Government of Saint Lucia have issued simultaneously a joint communique concerning the establishment of diplomatic relations between the two countries, the text of which is as follows:

The Government of Saint Lucia and the Government of the Sultanate of Oman, desirous of developing and strengthening their relations in the interest of peace and cooperation among peoples, and on the basis of mutual respect for independence, sovereignty and territorial integrity, as well as on the principles of non-interference in internal affairs of any country, on the non-use of force in international relations, of the pacific settlement of disputes and of other principles enshrined in the Charter of the United Nations, have agreed to establish diplomatic relations at ambassadorial level, as of March 28, 1984.

We would request you to transmit this communication to States Members of the United Nations and we take this opportunity to renew to you the assurances of our highest consideration.


