
Excellency,



JOINT COMMUNIQUE

The Governments of the People's Republic of Angola and the Republic of Venezuela have agreed to establish bonds of friendship and cooperation on the basis of the principles of mutual respect of national sovereignty, territorial integrity, non-interference in the internal affairs of each other and equal rights.

Desiring to obtain this objective, the two Governments have decided to establish formal diplomatic relations as of December 9, 1986.

The Governments of both countries express the hope that the establishment of diplomatic relations will lead to the development of mutually beneficial cooperation.
