COOPERATION BETWEEN THE UNITED NATIONS AND THE LEAGUE OF ARAB STATES

and Yemen: draft resolution

The General Assembly,

<u>Recalling</u> its previous resolutions on the promotion of cooperation between the United Nations and the League of Arab States,

 $\underline{\text{Having considered}}$  the report of the Secretary-General on cooperation between the United Nations and the League of Arab States,  $\underline{1}/$ 

<u>Recalling also</u> the decision of the Council of the League of Arab States that it considers the League a regional organization within the meaning of Chapter VIII of the Charter of the United Nations,

<u>Noting</u>, on the eve of the fiftieth anniversary of the United Nations and the League of Arab States, the desire of both organizations to consolidate, develop and enhance further the ties existing between them in the political, economic, social, humanitarian, cultural and administrative fields,

<u>Taking into account</u> the report of the Secretary-General entitled "An Agenda for Peace",  $\underline{2}$ / in particular section VII, concerning cooperation with regional arrangements and organizations,

 $\underline{\text{Convinced}}$  that the maintenance and further strengthening of cooperation between the United Nations system and the League of Arab States contribute to the promotion of the purposes and principles of the United Nations,

<u>Convinced also</u> of the need for more efficient and coordinated utilization of available economic and financial resources to promote common objectives of the two organizations,

<u>Recognizing</u> the need for closer cooperation between the United Nations system and the League of Arab States and its specialized organizations in realizing the goals and objectives of both organizations,

<u>Welcoming</u> the meeting between the Secretary-General and heads of regional organizations on peace at United Nations Headquarters on 1 August 1994,

Welcoming also the sectoral meeting on human resource development in rural areas between the representatives of the secretariats of the United Nations system and the General Secretariat of the League of Arab States and its specialized organizations, held at Vienna on 14 and 15 July 1994,

- 1. Takes note with satisfaction of the report of the Secretary-General;  $\underline{1}/$
- 2. <u>Commends</u> the continued efforts of the League of Arab States to promote multilateral cooperation among Arab States, and requests the United Nations system to continue to lend its support;
- 3. <u>Takes note</u> of the conclusions and recommendations adopted at the sectoral meeting on human resource development in rural areas between the representatives of the secretariats of the United Nations system and the General Secretariat of the League of Arab States and its specialized organizations, held at Vienna on 14 and 15 July 1994;
- 4. Expresses its appreciation to the Secretary-General for the follow-up action taken by him to implement the proposals adopted at the meetings between the representatives of the secretariats of the United Nations and other organizations of the United Nations system and the General Secretariat of the League of Arab States and its specialized organizations, held at Tunis in 1983, 3/ at Amman in 1985 4/ and at Geneva in 1988 5/ and 1993; 6/
- 5. <u>Expresses its appreciation</u> to the organizational entities of the United Nations system and the League of Arab States and its specialized

organizations for their contributions leading to the success of the sectoral meeting on human resource development in rural areas;

- 6. Requests the Secretariat of the United Nations and the General Secretariat of the League of Arab States, within their respective fields of competence, to intensify further their cooperation towards the realization of the purposes and principles of the Charter of the United Nations, the strengthening of international peace and security, economic development, disarmament, decolonization, self-determination and the eradication of all forms of racism and racial discrimination;
- 7. <u>Expresses its appreciation</u> to the Secretary-General for his initiative in meeting with heads of regional organizations on 1 August 1994, and recommends that consideration be given to the organization of further meetings;
- 8. Requests the Secretary-General to continue his efforts to strengthen cooperation and coordination between the United Nations and other organizations and agencies of the United Nations system and the League of Arab States and its specialized organizations in order to enhance their capacity to serve the mutual interests of the two organizations in the political, economic, social, humanitarian, cultural and administrative fields;
- 9. <u>Also requests</u> the Secretary-General to continue to coordinate the follow-up action to facilitate the implementation of the proposals of a multilateral nature adopted at the Tunis meeting in 1983 and to take appropriate action regarding the proposals adopted at previous meetings, including the following:
- $(\underline{a})$  Promotion of contacts and consultations between the counterpart programmes of the United Nations system;
  - (b) Setting up joint sectoral inter-agency working groups;
- 10. <u>Calls upon</u> the specialized agencies and other organizations and programmes of the United Nations system:
- $(\underline{a})$  To continue to cooperate with the Secretary-General and among themselves, as well as with the League of Arab States and its specialized organizations, in the follow-up of multilateral proposals aimed at strengthening and expanding cooperation in all fields between the United Nations system and the League of Arab States and its specialized organizations;
- $(\underline{b})$  To maintain and increase contacts and improve the mechanism of consultation with the counterpart programmes, organizations and agencies concerned regarding projects and programmes, in order to facilitate their implementation;
- $(\underline{c})$  To associate whenever possible with organizations and institutions of the League of Arab States in the execution and implementation of development projects in the Arab region;

- $(\underline{d})$  To inform the Secretary-General, not later than 15 May 1995, of the progress of their cooperation with the League of Arab States and its specialized organizations, in particular the follow-up action taken on the multilateral and bilateral proposals adopted at the previous meetings between the two organizations;
- 11. <u>Decides</u> that, in order to intensify cooperation and for the purpose of review and appraisal of progress as well as to prepare comprehensive periodic reports, a general meeting between the United Nations system and the League of Arab States should take place once every two years, and inter-agency sectoral meetings should be organized annually on areas of priority and wide importance in the development of the Arab States;
- 12. <u>Recommends</u>, on the occasion of the fiftieth anniversary of the United Nations and the League of Arab States, that the next general meeting on cooperation between the representatives of the secretariats of the United Nations system and the General Secretariat of the League of Arab States and its specialized organizations be held during 1995;
- 13. Requests the Secretary-General of the United Nations, in cooperation with the Secretary-General of the League of Arab States, to encourage periodic consultation between representatives of the Secretariat of the United Nations and the General Secretariat of the League of Arab States to review and strengthen coordination mechanisms with a view to accelerating implementation and follow-up action of multilateral projects, proposals and recommendations adopted at the meetings between the two organizations;
- 14. <u>Also requests</u> the Secretary-General to submit to the General Assembly at its fiftieth session a progress report on the implementation of the present resolution;
- 15.  $\underline{\text{Decides}}$  to include in the provisional agenda of its fiftieth session the item entitled "Cooperation between the United Nations and the League of Arab States".
