Excellency,




**JOINT COMMUNIQUE**

The Government of the Republic of Poland and the Government of Saint Lucia inspired by their desire to develop friendly relations and cooperation on the basis of mutual respect, national sovereignty, territorial integrity, non-interference and equal rights, based on international law, the Charter of the United Nations and the Vienna Convention on Diplomatic Relations,


Have decided to establish diplomatic relations at Ambassadorial level, with effect from the date of signing of this Joint Communiqué.
