PART-TIME WORK FOR WOMEN: A SELECTED BIBLIOGRAPHY

1. At its seventh session, the Commission on the Status of Women "expressed the wish that the Secretary-General would prepare a bibliography of books and pamphlets" on the subject of part-time work for women.
2. The following list has been prepared in accordance with this request and includes the titles of books, pamphlets and periodical articles which were available to the Secretary-General. The list has been divided under the headings of general material, material on part-time work in particular occupations, and material on war-time experience, so as to facilitate reference.
3. Sources (other than the non-published reports on part-time work submitted by non-governmental organizations) used in the preparation of the two reports on Part-time Work for Women^{1/} have been included in this bibliography.
