## REVISION OF THE FORM OF ANNUAL REPORTS

### Note by the Secretary-General

1. At its eighth session the Commission requested the Secretary-General to draft a revised text of the form of annual reports, for consideration at its ninth session.
2. The following points regarding the revised text attached may be mentioned:
  - (a) Questions which had been added ad hoc at different times (for instance, relating to heroin and synthetic drugs) have been consolidated in the text.
  - (b) A certain amount of re-arrangement, taking into account the general scheme of the main documents prepared annually for the Commission and the way in which it normally makes up its agenda, has also been attempted. It will be noted that, in many cases, there are a number of questions which can be put under more than one head in the form; in several such cases, where the advantages seem balanced fairly evenly, attention has been drawn to this in footnotes.
  - (c) In order to avoid unnecessary work and duplication, a large number of questions have been re-drafted so as to ask only for changes, or new information; the basic information, law, etc., having already been included in documents submitted to the Commission.
  - (d) A few questions have been omitted as obsolete or because they have not in practice been providing useful information for the Commission.

(e) It is assumed that, in accordance with practice in recent years, the Commission wishes to utilize the form to request appropriate information in connexion with subjects to which it is giving special attention. As regards such questions, it may be anticipated that the form will be subject to revision at shorter intervals than for the form as a whole.

(f) Attempts have been made to clarify the text in instances where there has been misunderstanding in past years.

3. For the convenience of the Commission, a number of footnotes have been included prefaced by the words "Note for the Commission". These are not intended to form part of the form as eventually approved. Footnotes not so prefaced are intended to form part of the form.

4. The numbers of corresponding, and partly corresponding, questions in the present form (E/NR.1953/Form) are noted in the left-hand margin. In a few cases, the component parts of the existing question are represented under different headings in the draft.
