Report of the Conference on Disarmament

The General Assembly,

<u>Having considered</u> the report of the Conference on Disarmament, $\frac{1}{2}$

<u>Convinced</u> that the Conference on Disarmament, as the single multilateral disarmament negotiating forum of the international community, has the primary role in substantive negotiations on priority questions of disarmament,

<u>Considering</u>, in this respect, that the present international climate should give additional impetus to multilateral negotiations with the aim of reaching concrete agreements,

 $\underline{\text{Welcoming}}$ the ongoing negotiations of the Conference on Disarmament on a comprehensive nuclear-test-ban treaty,

<u>Noting</u> with satisfaction the results achieved so far on the subject of improved and effective functioning of the Conference on Disarmament, as well as the decision to carry out consultations with a view to achieving consensus on the issue of its membership by the beginning of its 1995 session and the decision to continue consultations on the issue of the agenda at its 1995 session,

- 1. <u>Reaffirms</u> the role of the Conference on Disarmament as the single multilateral disarmament negotiating forum of the international community;
- 2. <u>Welcomes</u> the determination of the Conference on Disarmament to fulfil that role in the light of the evolving international situation, with a view to making early substantive progress on priority items of its agenda;
- 3. <u>Urges</u> the Conference on Disarmament to intensify its negotiations to conclude a comprehensive nuclear-test-ban treaty;
- 4. <u>Urges</u> the Conference on Disarmament to make every effort to reach a solution on the expansion of its membership by the beginning of its 1995 session;
- 5. <u>Encourages</u> the ongoing review of the agenda, membership and methods of work of the Conference on Disarmament;
- 6. <u>Requests</u> the Secretary-General to continue to ensure the provision, to the Conference on Disarmament, of necessary administrative, substantive and conference support services;
- 7. Requests the Conference on Disarmament to submit a report on its work to the General Assembly at its fiftieth session;
- 8. $\underline{\text{Decides}}$ to include in the provisional agenda of its fiftieth session an item entitled "Report of the Conference on Disarmament".
