

***on the establishment of diplomatic relations***

**Romania and the Republic of Nauru,**

Desirous of strengthening the relations of friendship and cooperation between the two countries,

On the basis of the principles and purposes of the Charter of the United Nations and international law, particularly on international peace and security, equality among States, national sovereignty, independence, international treaties, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Joint Communiqué.
