We kindly request Your Excellency to have this letter and the Joint Communiqué circulated as United Nations documents.





The Government of Solomon Islands and the Government of the Republic of Estonia,


With the purpose to promote mutual understanding and strengthen the friendship and co-operation among their two peoples,
