**Joint Communiqué on the Establishment of Diplomatic Relations between the
Government of the Republic of Kazakhstan and the Government of
Saint Lucia**

The Government of the Republic of Kazakhstan and the Government of Saint Lucia, desiring to develop and strengthen relations of friendship and cooperation between their two countries and in conformity with the principles of equality and sovereignty between States and in full respect of their territorial integrity, have decided to establish diplomatic relations at the Ambassadorial level as of the date of signature of this Joint Communiqué, in accordance with the provisions of the Vienna Convention on Diplomatic Relations, dated 18 April 1961, and on the basis of principles enshrined in the Charter of the United Nations.

Done in New York on 5 December 2012 in duplicate, in English and Kazakh, both texts being equally authentic.
