JOINT COMMUNIQUE

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF BELARUS AND THE REPUBLIC OF LIBERIA

Guided by the principles and purposes of the United Nations Charter, the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963,

Have decided to establish diplomatic relations between the Republic of Belarus and the Republic of Liberia as of the date of the signing of this Joint Communiqué.
