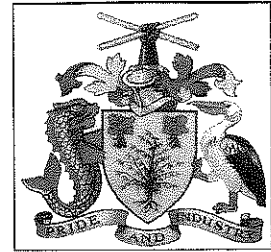

**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN GEORGIA AND BARBADOS**

The Government of Georgia and the Government of Barbados,

Desirous of promoting mutual understanding and cooperation between their two countries and peoples,

Based on the principle of mutual respect for territorial integrity and non-intervention in the internal affairs of each other, as well as norms of international law and the objectives and principles of the United Nations Charter,

Have agreed to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué.

In witness whereof, the undersigned Representatives, duly authorised by their respective Governments, have signed this Joint Communiqué in two originals, in Georgian and English languages, the two texts being equally authentic.
