## انتخاب أعضاء اللجنة الاستشارية لمجلس حقوق الإنسان\*

## مذكرة من الأمين العام

١- عملاً بقرار مجلس حقوق الإنسان ١/٥، ينتخب المجلس، في اقتراح سري من قائمة المرشحين الذين قُدِّمَت أسماءهم وفقاً للشروط المتفق عليها، أعضاء اللجنة الاستشارية، المؤلفة من ١٨ خبيراً يعملون بصفتهم الشخصية ورشحتهم الدول الأعضاء في الأمم المتحدة بعد التشاور مع المؤسسات الوطنية لحقوق الإنسان ومنظمات المجتمع المدني.

٢- ويكون التوزيع الجغرافي للأعضاء على النحو التالي:

(أ) خمسة أعضاء من الدول الأفريقية؛

(ب) خمسة أعضاء من دول آسيا والمحيط الهادئ؛

(ج) عضوان من دول أوروبا الشرقية؛

(د) ثلاثة أعضاء من دول أمريكا اللاتينية ومنطقة البحر الكاريبي؛

(هـ) ثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٣- واعتمد مجلس حقوق الإنسان، في دورته السادسة، المقرر ١٠٢/٦ المتعلق بمتابعة تنفيذ القرار ١/٥ الذي حدد فيه الشروط التقنية والموضوعية لتقديم أسماء المرشحين. وهي تشمل ما يلي:

(أ) الكفاءة والخبرة المشهود بهما في مجال حقوق الإنسان؛

(ب) أن يكون المرشح على حُلق؛

(ج) الاستقلال والنزاهة.

\* يُعَمَّم مرفق هذا التقرير كما ورد باللغات التي قُدِّمَ بها فقط.



٤- ويتعين على الدول، عند اختيار مرشحيها، أن تطبق المبادئ التوجيهية التالية المتعلقة بالشروط التقنية والموضوعية لتقديم مرشحيها:

(أ) الكفاءة والخبرة:

- '١' دراسات أكاديمية في مجال حقوق الإنسان أو الميادين المتصلة به و/أو الخبرة مع أداء أدوار قيادية في مجال حقوق الإنسان على المستوى الوطني أو الإقليمي أو الدولي؛
- '٢' خبرة طويلة (لا تقل عن خمس سنوات) وإسهامات شخصية في مجال حقوق الإنسان؛
- '٣' الدراية بمنظومة الأمم المتحدة وبالولايات والسياسات المؤسسية المتصلة بالعمل في مجال حقوق الإنسان، وكذلك الدراية بالصكوك والمعايير والتخصصات الدولية في مجال حقوق الإنسان؛ ويُجذد الإمام بمختلف النظم القانونية والحضارات؛
- '٤' إجادة لغة واحدة على الأقل من لغات الأمم المتحدة الرسمية؛
- '٥' توافر الوقت الكافي لدى المرشح لأداء عمل اللجنة الاستشارية على نحو فعال، بحضور دورات اللجنة والاضطلاع بالأنشطة التي تصدر بها تكاليفات بين الدورات.

(ب) أن يكون المرشح على حُلق؛

- (ج) الاستقلال والنزاهة: يُستبعد الأفراد الذين يشغلون مناصب صنع القرارات في الحكومة أو في أي منظمات أو كيانات أخرى قد يترتب على تقلدها تعارض في المصالح مع المسؤوليات الأساسية للولاية؛ ويعمل أعضاء اللجنة الاستشارية المنتخبون بصفتهم الشخصية؛
- (د) اعتبارات أخرى: يجب احترام مبدأ عدم الجمع في آنٍ واحد بين عدة مهام في مجال حقوق الإنسان.

٥- وعلى مجلس حقوق الإنسان أن يولي الاعتبار الواجب للتوازن بين الجنسين ولتمثيل النظم القانونية والحضارات المختلفة التمثيل المناسب عند انتخاب أعضاء اللجنة الاستشارية.

٦- وأجرى مجلس حقوق الإنسان، في دورته السابعة، الانتخابات الأولى لأعضاء اللجنة الاستشارية الثمانية عشر. وانتخب أربعة أعضاء لمدة سنة واحدة وسبعة لمدة سنتين وسبعة لمدة ثلاث سنوات.

٧- وسيُنتخب مجلس حقوق الإنسان، في دورته التاسعة والثلاثين، وفقاً لبرنامج عمله السنوي، أعضاء اللجنة الاستشارية لشغل المناصب الأربعة الشاغرة. ومن المقاعد الأربعة الشاغرة، يعود مقعد لدول أفريقيا، ومقعد لدول آسيا والمحيط الهادئ، ومقعد لدول أمريكا اللاتينية ومنطقة البحر الكاريبي، ومقعد لدول أوروبا الغربية ودول أخرى.

٨- وعملاً بأحكام الفقرة ٧١ من قرار مجلس حقوق الإنسان ١/٥، تُقفل قائمة المرشحين قبل شهرين من تاريخ الانتخاب، وتُنصح الأمانة قائمة المرشحين والمعلومات المتوفرة عنهم للدول الأعضاء والجمهور قبل شهر على الأقل من تاريخ الانتخاب.

٩- وفي ١١ نيسان/أبريل ٢٠١٨، وجّهت أمانة مجلس حقوق الإنسان مذكرة شفوية إلى المنسقين الإقليميين المعنيين، تحثهم فيها على اقتراح أسماء مرشحين وتعلمهم أن الموعد النهائي لتقديم أسماء المرشحين هو ٢٢ أيار/مايو ٢٠١٨، وهو الموعد الذي مُدِّد لاحقاً إلى ٢٥ تموز/يوليه ٢٠١٨<sup>(١)</sup>.

١٠- وتبعاً لذلك، تلقت الأمانة أسماء ستة مرشحين للانتخاب أعضاء في اللجنة الاستشارية من حكومات البرازيل، وإيران (جمهورية - الإسلامية)، وإيطاليا، وقطر، والمملكة العربية السعودية، والسنغال.

Dr. Al-Kuwari graduated as a Civil Engineer from Cairo University in 1980. He then joined the graduate school in Ain Shams University and obtained a Master's in Civil Engineering, and later went back Cairo University and obtained his Ph.D. in Civil Engineering (concrete and Asphalt) in 1992. He also holds a Diploma in languages from Languages' Institute, Qatar and Swandeen language school, England, UK. In 1986.

Dr. Al-Kuwari was served as an Assistant Undersecretary for Standardization in Ministry of Environment and was formerly Director General of the Qatar General Organization for Standards and Metrology (QGOSM) (during the period 2002–2016). He is currently an Assistant Undersecretary-Director of Environmental and Municipal Studies Institute, consultant and engineering expert in ministry of Municipality and environment and United Nations Commissioner for Evangelization of the United Nations goals for sustainable development, 2016.

In 2010, Dr. Mohamed was selected a member of the National Committee for Human Rights in Qatar, and in 2014 Dr. Mohamed was awarded an international ambassador for social responsibility of the CSR Regional Network. It also awarded the Scientific Efficiency Award for Sustainable Development in 2017 for scientific and professional efforts in sustainable development.

Dr. Al-Kuwari authored 14 books in various scientific and environmental issues and contributed more than 39 scientific and technical research papers in the fields of materials engineering, buildings and construction specifications and other general areas. He was also invited to speak in more than 40 venues ranging from technical lectures to general public awareness seminars.

Dr. Al-Kuwari represented the State of Qatar in more than 90 regional and international meeting and venues, most of which were related to Housings, Standardization, International Trade and Human Rights.
