# JOINT COMMUNIQUE

# ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

#### **BETWEEN**

#### THE STATE OF BAHRAIN

#### AND

### REPUBLIC OF MALAWI

"The Government of the State of Bahrain and the Government of the Republic of Malawi, desirous of promoting and strengthening the friendly relations between them and developing bi-lateral cooperation in various fields of concern to both countries, and being interested to develop relations between the two countries on the basis of mutual respect, sovereignty, territorial integrity and non-interference in internal affairs; and confirming their commitment to the objectives and principles of the United Nations in consolidating international peace and security; have decided to establish formal diplomatic relations at the Ambassadorial level in accordance with the provisions of the Vienna Convention on diplomatic relations of April 18, 1961".
