**COOPERATION AND COORDINATION OF ACTIVITIES WITH
OTHER INTERNATIONAL ORGANIZATIONS AND INSTITUTIONS**

Note by the Executive Secretary

1. Since its forty-seventh session the Commission and its secretariat, in response to Commission decision O (45), have further strengthened their cooperation and coordination of activities with other international economic organizations and institutions, including bodies of the United Nations and its specialized agencies. This cooperation and coordination continues to be an important feature of the Commission's methods of work to ensure the optimum use of resources and expertise and to avoid duplication of activities. The wide range of organizations with which ECE cooperates reflects the dual capacity of the ECE as a United Nations programme and a regional body cooperating closely with other European institutions.

2. This note is divided into three parts. The first provides a detailed account of ECE's cooperation with organizations and institutions with which the ECE is encouraged to intensify its cooperation and coordination under the terms of decision O (45). They are as follows: the European Community, OECD, EBRD, IMF, the World Bank and GATT. The second part presents in the form of a synoptic table ECE's cooperation with other international and intergovernmental organizations. Part three contains a list of non-governmental organizations which have participated actively in the work of the ECE since the forty-seventh session.
