ANNEX

Letter from the Federal Minister for Foreign Affairs of the
Federal Republic of Yugoslavia to the Secretary-General

I would like to inform you that the Government of the Federal Republic of Yugoslavia has been following with attention the considerations to determine the contributions of the Federal Republic of Yugoslavia to the United Nations budget. I wish to underline in the first place that the Federal Republic of Yugoslavia as a Member of the United Nations, continuing the personality of the Socialist Federal Republic of Yugoslavia under international law, and as a founding Member of the United Nations, will continue to fulfil its obligations under the United Nations Charter and the decisions of the respective United Nations bodies. Accordingly the Federal Republic of Yugoslavia will also meet its obligations concerning the United Nations budget.

In view of the fact that the solution proposed in the previous considerations of this matter within the Committee on Contributions and in the Fifth Committee of the General Assembly does not fully reflect the complex situation in the territory of the former Socialist Federal Republic of Yugoslavia, I would like to draw your attention to some points which could facilitate the adoption of an objective and just decision on the proper contribution of the Federal Republic of Yugoslavia and the newly admitted States Members of the United Nations from the territory of the former Socialist Federal Republic of Yugoslavia, including the payment modalities of the outstanding debt of the Socialist Federal Republic of Yugoslavia.

The contribution rate of the Federal Republic of Yugoslavia to the United Nations budget can be calculated exclusively on the basis of the figures concerning the present gross national product and national income of the Republics of Serbia and Montenegro and their respective populations, which are already incorporated in the United Nations statistics. The previously established method of taking the 10-year average national income of the former Socialist Federal Republic of Yugoslavia is unrealistic and objectively outdated owing to the consequences of the war in the former Socialist Federal Republic of Yugoslavia, implementation of the United Nations sanctions on the Federal Republic of Yugoslavia and special difficulties created by 500,000 refugees living in the territory of the Federal Republic of Yugoslavia, as a result of which the accepted principle of "payment ability" must be taken into account.

It is unacceptable to include the former Yugoslav Republic of Macedonia in the contribution rate of the Federal Republic of Yugoslavia because that State is not an integral part of the Federal Republic of Yugoslavia and consequently the latter cannot be held responsible for its obligations.

The outstanding debt of the Socialist Federal Republic of Yugoslavia until the admission of the former Yugoslav Republics to the United Nations or, possibly, until their proclamation of independence, will be reimbursed by the Federal Republic of Yugoslavia in accordance with the constitutional provisions concerning the assumption of international obligations of the Socialist Federal Republic of Yugoslavia (reserving the right that these funds be reimbursed from the secessionist Republics as allocated to them by the final decision on

division of assets and liabilities of the Socialist Federal Republic of Yugoslavia within the Geneva Conference).

I am convinced that all circumstances have been met for the United Nations Secretariat to modify its methodology of presenting the debt of the Socialist Federal Republic of Yugoslavia, respectively to separate the presentation of this debt from the liabilities of the Federal Republic of Yugoslavia in the future.
