## II. ANNOTATIONS TO THE PROVISIONAL AGENDA

### Item 1: Election of officers

1. Under rule 64, paragraph 3, of the Rules of Procedure of the Trade and Development Board, each subsidiary organ of the board shall elect its own officers. In accordance with the cycle of rotation for the election of Chairman and Vice-Chairman-cum-Rapporteur of the Working Party, the Chairman of the Working Party at its twenty-second session (the first of a seven-session cycle) shall be a representative of one of the States members in List B and the Vice-Chairman-cum-Rapporteur a representative of one of the States members in List C.

### Item 2: Adoption of the agenda and organization of work

2. The provisional agenda for the twenty-second session of the Working Party, as reproduced in section I above, was approved by the Working Party at its 98th plenary meeting, on 8 September 1992.

3. In deciding upon the organization of work, the Working Party may wish to consider the suggestions contained in the tentative timetable annexed to the present document.

### Item 3: Review of the UNCTAD section of the proposed United Nations programme budget for the biennium for 1994 - 1995

4. The Working Party will have before it, under cover of document (TD/B/WP(XXII)/Misc.1), a draft of the UNCTAD work programme in the context of the preparation of the proposed programme budget for the biennium 1994 - 1995. The proposed programme budget will be submitted to the General Assembly at its forty-eighth session.

5. The Working Party will also have before it in document (TD/B/WP(XXII)/Misc.2), a work programme narrative for 1993 based on the reorientations resulting from decisions of the eighth session of the Conference, the Board and its new Standing Committees and Ad Hoc Working Groups.

6. The UNCTAD secretariat will submit to the Working Party for its consideration a draft provisional agenda for its twenty-third session.
