LETTER DATED 21 DECEMBER 1992 FROM THE SECRETARY-GENERAL ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

Further to my letter dated 17 December 1992 (S/24900 Add.4) and in accordance with paragraph 4 of Security Council resolution 781 (1992), I should like to share with the Council further information received by UNPROFOR regarding apparent violations of the ban on military flights in the airspace of Bosnia and Herzegovina.

Between 17 December and 19 December, there appear to have been seven flights of fixed or rotary wing aircraft in the airspace of Bosnia and Herzegovina other than those exempted in accordance with operative paragraph 1 of resolution 781 (1992) or approved by UNPROFOR in accordance with operative paragraph 3 of that resolution. Details as to the time and the itinerary of these flights are attached as an annex to this letter.

All confirmed violations were immediately protested by UNPROFOR to the party concerned.

I have to draw the Council's attention to the fact that recently the United Nations Military Observers (UNMOs) deployed at the two airfields in Banja Luka are experiencing restrictions of their freedom of movement between the airfields and their choice of living accommodation. Moreover, at the airfield in Cazin, the UNMOs are prevented from inspecting the cargo of incoming and outgoing flights. UNPROFOR has protested these restrictions and is in contact with the concerned authorities in order to redress the situation. I will keep the Security Council informed on any progress made in this regard.
