

JOINT COMMUNIQUE

On the Establishment of Diplomatic Relations Between The Republic of El Salvador and the People's Republic of Bangladesh

The Government of the Republic of El Salvador and the Government of the People's Republic of Bangladesh;

DESIROUS of promoting the friendly relations existing between the two countries and strengthening their bilateral cooperation on a mutually advantageous grounds and on the basis of the principles of international law, in particular, principles of sovereign equality, territorial integrity, inviolability of frontiers of sovereign States and non-interference in the internal affairs of other States;

GUIDED by the principles and objectives of the Charter of the Organization of the United Nations and the provisions of the Vienna Convention on Diplomatic relations of 18 April 1961;

Have decided to establish diplomatic relations with effect from the date of the signature of the present Joint Communiqué.

In witness thereof, the undersigned Plenipotentiaries, duly authorized by their respective Governments, have signed present Joint Communiqué.

Han decidido Establecer Relaciones Diplomáticas, con efectos a partir de la fecha de la firma del presente Comunicado Conjunto.


