Bhutan

"... would like to take this opportunity of requesting the assistance of the UNCTAD Technical Cooperation Programme on GSP in serving notifications to the concerned authorities in the respective preference-giving countries under the GSP scheme. We feel that serving notifications through UNCTAD would be effective as it being the focal organization in such matters. We, therefore, would like to request UNCTAD to kindly facilitate delivery of the communication enclosed herewith to the authorities of the concerned preference-giving countries."³
