Sir,

COMPLAIN

We banyarwanda reminding you Sir, about our Complaints for the Refugees in Uganda, runing from Ruanda Country for bad behave of Beligians.

We surprised very much, when we arrived in Uganda safely. Then the Government of Beligian tried to took us back in "HORRIBLY" country of Ruanda, because of firing our brother without any reason, or to give Statement. And the Uganda Government was very very anoyed for that Horrible action.

Therefore we imform the United Nations of America that we do not agree with this bad action of "FIRING" our brothers, because of bad rulling of Beligians. Instead of organizing their people the Government selects the action of Kiling them.

Perticularly we Moslems, whe we tried to Publish the bad ruling to Beligians, and tried to report to the U. N. O. asking for the Freedom, so that we may not perscuted like other peoples,. But instead of getting Freedom Government of Beligians started to perscute us and put us in Prisons For Example:- Muwalimu Alamanzane, M sitafa, was put in Prison without any reason,

because of Moslers reported Beligians to the U.N.O. for their bad habits, done by their Government.

We inform the U.N.O. that the Moslems situated in Ruanda are in terrible life, they no where to pass for their food, or in the Shops and Markets, so that they are really starving. So we humbly apply the U.N.O. to save our brothers so that may not completly finished for death, by the Beligians, like in othe Countries of COLONY.

Please save us in death; and we are again inform you the U.N.O. that the Government of Beligians is unfit., because of killing Banyaruanda without any reason. So we beg U.N.O. to take off that Terrible Government, as soon as possible. But we shall not allow to have self-Government of such bad rulling. U.N.O. must show its power, may return THE UMWAMI KIGERI V n his country of Ruanda, so that the peace may come.

It shows itself that the present Government knows nouthing about ruling, so the Government may leave as soon as possible, s that we may select a new Government of a peace. Because the Government will be organized by the UMNAMI KIGERI V, as the HEAD OF STATE, and he will deal with U.N.O. so that we may have peaceful- Government.

For the maighty of the U.N.O., we request to reply us, and tell us all what will be in your meeting, about this matter. And you may tell us what kind of Government, will be in Ruanda and you may show us the Possition of the Umwami Kigeri V, in the Selfe-Government of Ruanda. We are not ready to have Self-Government before we understand the possition of the Umwami Kigeri V, unless you inform us the possition, and what sort of type of Government selected by the majority.

... But we dislike the present Government of Terrible life. We request the U.N.O., if it fails to full-fill our Statement of Complaining to our brothers in Ruanda May give us, the power to inter in our Country by force, and take away the bad government of Beligians. Because of waiting so long time and tied of Beligians.
