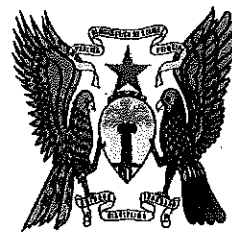

We have the honour to inform you that today the Federation of Saint Kitts and Nevis and the Democratic Republic of Sao Tome and Principe have established diplomatic relations.



JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE FEDERATION OF SAINT KITTS AND NEVIS AND THE DEMOCRATIC REPUBLIC OF SÃO TOMÉ AND PRÍNCIPE

The Federation of Saint Kitts and Nevis and the Democratic Republic of São Tomé and Príncipe,

In order to promote mutual understanding and strengthening the friendship and cooperation between the two countries,


Guided by the principles and purposes enshrined in the Charter of the United Nations and the principles international law,

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of the 18 April 1961, as of the signing of this Joint Communiqué,

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two duplicates, in English and Portuguese, both texts being equally authentic.


