Please accept, Excellency, the assurances of our highest consideration.

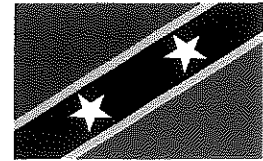

JOINT COMMUNIQUÉ
On the Establishment of Diplomatic Relations
Between
The Kingdom of Cambodia
and
The Federation of Saint Kitts and Nevis



The Kingdom of Cambodia and the Federation of Saint Kitts and Nevis,

Desiring to promote mutual understanding and consolidate relations of friendship and cooperation between their peoples;

Being guided by the principles and objectives of the Charter of the United Nations and international law, particularly for the purpose of respect and strengthening of international peace and security, equality between State and State, national sovereignty, independence, international agreement, territorial integrity, and non-interference in internal affairs between State and State;

Have decided to establish the diplomatic relations at Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of signing this Joint Communiqué;

In witness whereof, the undersigned Representatives, being duly authorized by their respective Governments, have signed this Joint Communiqué in duplicate, Khmer and English languages, all texts being equally authentic.
