Dear Sir;

We hereby come to inform you that the National Secretariat of One Kamerun has seen the public Notice emanating from you No. 2314/297 of the 2nd October C.JB/JF.

Being remained dumbfound before the contents of the said Notice, our Secretariat refering itself to the principle of freedom of speech, has deemed it necessary to get information about the forthcoming Visiting Mission of the UNO.

The "Daily Times" of the 2nd October bore in paragraph 4 in page 6 the Arrival and proceedings of their reception. In the said paragraph it was said that the Visiting Mission will receive Memoranda and delegations. If everything concerning the Visiting Mission could be carried out between 4 and 5 p.m. on the 31th October by the Government, how could the population express freely their wishes according to article 76 B of the UNO Charter? And how could the Mission not be unjust in receiving a few in a short time?

It was said by the colonial Secretary, the Trusteeship Council and the 12th Session of the General Assembly that the Visiting Mission is coming to make a popular consultation; we think that its not a Government consultation. There is no proof that the Government will not favour some people with their petitions. We want every one to see the Visiting Mission personally and express himself.

We ask the Government to leave Cameroon affairs between Cameroonians and the UNO.
