ESTABLISHMENT OF A NUCLEAR-WEAPON-FREE ZONE IN SOUTH ASIA

Report of the First Committee

Rapporteur: Mr. Peter GOOSEN (South Africa)

I. INTRODUCTION

1. The item entitled "Establishment of a nuclear-weapon-free zone in South Asia" was included in the provisional agenda of the forty-ninth session in accordance with General Assembly resolution 48/72 of 16 December 1993.

2. At its 3rd plenary meeting, on 23 September 1994, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.

3. At its 2nd meeting, on 13 October, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 53 to 66, 68 to 72 and 153. The deliberations on those items took place at the 3rd to 10th meetings, from 17 to 24 October (see A/C.1/49/PV.3-10). Structured discussions of specific subjects on the adopted thematic approach took place from 25 to 27 and on 31 October and 1 November. Consideration of draft resolutions on those items took place at the 12th to 16th meetings, on 3, 4, 7 and 9 November (see A/C.1/49/PV.12-16). Action on draft resolutions on those items took place at the 19th to 25th meetings, from 14 to 18 November (see A/C.1/49/PV.19-25).

4. In connection with item 59, the First Committee had before it the following documents:

(a) Report of the Secretary-General on the establishment of a nuclear-weapon-free zone in South Asia (A/49/296);

(b) Letter dated 25 June 1994 from the Minister for Foreign Affairs of Egypt to the Secretary-General transmitting the texts of the documents adopted by the Eleventh Ministerial Conference of the Movement of Non-Aligned Countries, held at Cairo from 31 May to 3 June 1994 (A/49/287-S/1994/894 and Corr.1).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.1/49/L.14

5. On 31 October, Bangladesh and Pakistan submitted a draft resolution entitled "Establishment of a nuclear-weapon-free zone in South Asia" (A/C.1/49/L.14). The draft resolution was introduced by the representative of Pakistan at the 21st meeting, on 16 November.

6. At the same meeting, the Committee adopted draft resolution A/C.1/49/L.14 by a recorded vote of 130 to 3, with 9 abstentions (see para. 7). The voting was as follows: 1/

Against: Bhutan, India, Mauritius.

1/ Subsequently the delegation of Djibouti indicated that it had intended to vote in favour of the draft resolution.

Abstaining: Algeria, Brazil, Cuba, Cyprus, Indonesia, Lao People's Democratic Republic, Madagascar, Myanmar, Viet Nam.

III. RECOMMENDATION OF THE FIRST COMMITTEE

7. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

Establishment of a nuclear-weapon-free zone in South Asia

The General Assembly,

Recalling its resolutions 3265 B (XXIX) of 9 December 1974, 3476 B (XXX) of 11 December 1975, 31/73 of 10 December 1976, 32/83 of 12 December 1977, 33/65 of 14 December 1978, 34/78 of 11 December 1979, 35/148 of 12 December 1980, 36/88 of 9 December 1981, 37/76 of 9 December 1982, 38/65 of 15 December 1983, 39/55 of 12 December 1984, 40/83 of 12 December 1985, 41/49 of 3 December 1986, 42/29 of 30 November 1987, 43/66 of 7 December 1988, 44/109 of 15 December 1989, 45/53 of 4 December 1990, 46/31 of 6 December 1991, 47/49 of 9 December 1992 and 48/72 of 16 December 1993 concerning the establishment of a nuclear-weapon-free zone in South Asia,

Reiterating its conviction that the establishment of nuclear-weapon-free zones in various regions of the world is one of the measures that can contribute effectively to the objectives of non-proliferation of nuclear weapons and general and complete disarmament,

Believing that the establishment of a nuclear-weapon-free zone in South Asia, as in other regions, will assist in the strengthening of the security of the States of the region against the use or threat of use of nuclear weapons,

Taking note with appreciation of the declarations issued at the highest level by the Governments of South Asian States that are developing their peaceful nuclear programmes, reaffirming their undertaking not to acquire or manufacture nuclear weapons and to devote their nuclear programmes exclusively to the economic and social advancement of their peoples,

Welcoming the recent proposal for the conclusion of a bilateral or regional nuclear-test-ban agreement in South Asia,

Taking note of the proposal to convene, under the auspices of the United Nations, a conference on nuclear non-proliferation in South Asia as soon as possible, with the participation of the regional and other concerned States,

Taking note also of the proposal to hold consultations among five nations with a view to ensuring nuclear non-proliferation in the region,

Considering that the eventual participation of other States, as appropriate, in this process could be useful,

Bearing in mind the provisions of paragraphs 60 to 63 of the Final Document of the Tenth Special Session of the General Assembly 2/ regarding the establishment of nuclear-weapon-free zones, including in the region of South Asia,

Taking note of the report of the Secretary-General, 3/

1. Reaffirms its endorsement, in principle, of the concept of a nuclear-weapon-free zone in South Asia;

2. Urges once again the States of South Asia to continue to make all possible efforts to establish a nuclear-weapon-free zone in South Asia and to refrain, in the meantime, from any action contrary to that objective;

3. Welcomes the support of all the five nuclear-weapon States for this proposal, and calls upon them to extend the necessary cooperation in the efforts to establish a nuclear-weapon-free zone in South Asia;

4. Requests the Secretary-General to communicate with the States of the region and other concerned States in order to ascertain their views on the issue and to promote consultations among them with a view to exploring the best possibilities of furthering the efforts for the establishment of a nuclear-weapon-free zone in South Asia;

5. Also requests the Secretary-General to report on the subject to the General Assembly at its fiftieth session;

6. Decides to include in the provisional agenda of its fiftieth session the item entitled "Establishment of a nuclear-weapon-free zone in South Asia".
