PETITION FROM THE LEADERS OF THE FULANI AND HAUSA OF WUM DIVISION CONCERNING THE CAMEROONS UNDER BRITISH ADMINISTRATION

Sirs,

Petition from the Fulanis and Hausas Community, Wum Division Southern Cameroons.

Subject of Petition: - Qualification of Voters for the Southern Cameroons forthcoming Plebiscite.

We the undersigned leaders of the Fulani and Hausas of this Division earnestly forward this Petition to the United Nations General Assembly for consideration.

Though the Assembly has not yet taken any final stand about the qualifications of Voters at the forthcoming Plebiscite, we wish that the Assembly vides the views of the Governments on qualifications as unbecoming for the following reasons:-

(I) That we not strangers in this Territory, for our grand parents were buried here and, that we were delivered in this Territory. The fact may be proved by a Question to the Cameroons Government as from when we started paying cattle tax here in the Southern Cameroons, and,

- (II) That we own a First Class Natural Resorce in this Territory, and pay as Jangali over two thirds of the whole Revenue of the Territory, and that our children are also given appointments in the Native Authorities of the Territory and are treated equally as Natives and staff of the Territory, and
- (III) That the areas we are at the moment occupying we have Official permits over them and if we are refused the right of citizenship, then one day the Government can just withdraw the said permits and the result will be, we just move away from the Territory. The above permits are known as Grazing permits.
- (IV) That during the General Election to the Southern Cameroons House of Assembly we were give the right to vote and yet the present Government won the Election so we see no reason for the Government's fear about the forthcoming Plebiscite.

. We hope and are looking forward to see the General Assembly's just and fair treatment in this matter.
