II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1: Adoption of the agenda and organization of work

The provisional agenda for the second session was approved at the first session of the Working Group (see TD/B/WG.1/4, para. 23 and annex II). As provided for in the UNCTAD calendar of meetings, the Working Group will have available to it five working days, from 28 June to 2 July 1993.

In accordance with the decision of the Working Group at its first session (see TD/B/WG.1/4, para. 10 (b)), arrangements have been made for a two-day seminar-type discussion on foreign investors' motivations (item 2 of the provisional agenda). This discussion will take place on 28 and 29 June. Non-governmental actors have been invited to attend.

During the remaining days, from 30 June to 2 July, the Ad Hoc Working Group will examine items 2 and 3, in the light of country experiences. A tentative programme is contained in the annex.

<u>Item 2</u>: <u>Consideration of global trends and issues, including</u> foreign investors' motivations

With a view to assisting the Working Group in its consideration of this item, the secretariat has prepared a study entitled "Foreign direct investment in developing countries: recent trends and policy issues" (TD/B/WG.1/7). The study contains a review of salient features of recent FDI trends; foreign investors' motivations; competitive advantages of host countries; and the role of host country policies.
