**Resolution 828 (1993)**  
of 26 May 1993

*The Security Council,*

*Having examined* the application of Eritrea for admission to the United Nations,<sup>11</sup>

*Recommends* to the General Assembly that Eritrea be admitted to membership in the United Nations.

*Adopted without a vote at the 3218th meeting.*

**Decision**

At the same meeting, following the adoption of resolution 828 (1993), the President made the following statement on behalf of the members:<sup>13</sup>

"The Security Council has decided to recommend to the General Assembly that Eritrea be admitted as a Member of the United Nations. On behalf of the members of the Security Council, I wish to extend my congratulations to Eritrea on this historic occasion.

"The Council notes with great satisfaction Eritrea's solemn commitment to uphold the purposes and principles of the Charter of the United Nations and to fulfil all the obligations contained therein. We look forward to the day in the near future when Eritrea will join us as a Member of the United Nations and to working closely with its representatives."

**E. Application of the Principality of Monaco**

**Decisions**
