MAINTENANCE OF INTERNATIONAL SECURITY

Report of the First Committee

Rapporteur: Mr. Peter GOOSEN (South Africa)

I. INTRODUCTION

- 1. The item entitled "Maintenance of international security" was included in the provisional agenda of the forty-ninth session in accordance with General Assembly resolution 48/84 A of 16 December 1993.
- 2. At its 3rd plenary meeting, on 23 September 1994, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.
- 3. At its 2nd meeting, on 13 October, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely items 53 to 66, 68 to 72 and 153. The deliberations on those items took place at the 3rd to 10th meetings, from 17 to 24 October (see A/C.1/49/PV.3-10). Structured discussions of specific subjects on the adopted thematic approach took place from 25 to 27 and on 31 October and 1 November. Consideration of draft resolutions on those items took place at the 12th to 16th meetings, on 3, 4, 7 and 9 November (see A/C.1/49/PV.12-16). Action on draft resolutions on those items took place at the 19th to 25th meetings, from 14 to 18 November (see A/C.1/49/PV.19-25).

II. CONSIDERATION OF DRAFT DECISION A/C.1/49/L.46

- 5. On 7 November, <u>France</u>, the <u>Russian Federation</u>, the <u>United Kingdom of Great Britain and Northern Ireland</u> and the <u>United States of America</u> submitted a draft decision entitled "Maintenance of international security" (A/C.1/49/L.46). The draft decision was introduced by the representative of the Russian Federation at the 20th meeting, on 15 November.
- 6. At the same meeting, the Committee adopted draft decision A/C.1/49/L.46 without a vote (see para. 7).

III. RECOMMENDATION OF THE FIRST COMMITTEE

7. The First Committee recommends to the General Assembly the adoption of the following draft decision:

Maintenance of international security

The General Assembly, recalling its resolution 48/84 A of 16 December 1993, decides to include in the provisional agenda of its fiftieth session the item entitled "Maintenance of international security".
