SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

- 1. Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit hereunder the list of items of which the Security Council is currently seized, with references in parentheses to the previous summary statements that have been issued covering consideration of each item.  $\underline{1}/$
- 2. It will be recalled that, in the interest of economy, the Secretary-General reproduces only once annually the full, up-to-date list of items of which the Security Council is seized. In fulfilment of his responsibility under rule 11, an addendum to the basic list is issued weekly, making reference to those items on which further action has been taken by the Council during the week covered or indicating that there has been no change during that period.
- 3. The last full summary statement (S/1994/20\*  $\underline{2}$ /) was issued on 20 January 1994. The last weekly addendum (S/1994/20/Add.51) covered developments up to 31 December 1994.
- 4. At its 3393rd meeting, held on 27 June 1994, the Security Council concluded its consideration of the item entitled "The question of South Africa", which was listed in the last full summary statement (S/1994/20\*, item No. 43) and which, in accordance with paragraph 4 of resolution 930 (1994), was removed from the list of matters of which the Council is seized.
- 5. Also during this period, as part of the efforts to improve the documentation of the Security Council, the members of the Council again reviewed the list of matters of which the Security Council is seized and the stage reached in their consideration (S/1994/20\*, para. 9, and Add. 3, 12, 14, 21 and 25). By a note dated 28 July 1994 (S/1994/896), the President of the Security Council communicated the decision of the Security Council to remove the following items from the above-mentioned list of matters of which the Security Council is seized (item numbers below correspond to the listing in paragraph 9 of document S/1994/20\*):

The President, with the consent of the Council, invited the representative of Bosnia and Herzegovina, at his request, to participate in the discussion without the right to vote.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for full text, <u>see S/PRST/1995/1;</u> to be issued in <u>Official Records of the Security Council, Fiftieth Year, Resolutions and decisions of the Security Council, 1995).</u>
