SUSTAINABLE DEVELOPMENT AND INTERNATIONAL ECONOMIC COOPERATION

Report of the Second Committee (Part I)*

Rapporteur: Mr. Ahmed Yousif MOHAMED (Sudan)

I. INTRODUCTION

1. At its 3rd plenary meeting, on 23 September 1994, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its forty-ninth session the item entitled:

"Sustainable development and international economic cooperation:

"(a) Trade and development;

"(b) Food and agricultural development;

"(c) Commodities;

"(d) Cultural development;

"(e) Integration of the economies in transition into the world economy;

"(f) Industrial development cooperation;

"(g) United Nations Conference on Human Settlements (Habitat II);

"(h) International cooperation for the eradication of poverty in developing countries;

"(i) United Nations initiative on opportunity and participation"

and to allocate it to the Second Committee.

2. The Second Committee held general discussions on the item at its 18th, 19th and 21st to 28th meetings, on 31 October and 2, 8, 10, 11 and 14 to 16 November. An account of the Committee's general discussion on the item is contained in the relevant summary records (A/C.2/49/SR.18, 19 and 21-28).
