ANNOTATIONS TO THE PROVISIONAL AGENDA

Prepared by the Secretary-General

Addendum

- 1. The present document has been prepared to complete the annotations to the provisional agenda of the Commission on Human Rights at its fifty-first session (E/CN.4/1995/1/Add.1). Its purpose is to bring to the attention of the Commission those resolutions adopted by the General Assembly at its forty-ninth session which are considered relevant to the agenda items of this session of the Commission. A list of those resolutions is contained in the annex.
- 2. The following paragraphs complete the annotations to the provisional agenda and also contain a number of revisions to the annotations contained in the earlier document.
- Item 4. Question of the violation of human rights in the occupied Arab territories, including Palestine
- 3. At its forty-ninth session, the General Assembly considered the reports of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories $(A/49/67,\ A/49/172)$ and A/49/511.

4. The General Assembly adopted resolution 49/36 A to D on 9 December 1994. In resolution A, the General Assembly requested the Special Committee, pending complete termination of the Israeli occupation, to continue to investigate Israeli policies and practices in the occupied Palestinian territory and other Arab territories occupied by Israel since 1967.

Item 8. Question of the realization of the right to development

5. In its resolution 49/183 of 23 December 1994, entitled "Right to development", the General Assembly called upon the Commission on Human Rights to continue to make proposals to the General Assembly, through the Economic and Social Council, on the future course of action on the question, in particular on practical measures for the implementation and enhancement of the Declaration on the Right to Development, taking into account the conclusions and recommendations of the Global Consultation on the Realization of the Right to Development as a Human Right and the report of the Working Group on the Right to Development.

Item 9. The right of peoples to self-determination and its application to peoples under colonial or alien domination or foreign occupation

- 6. In its resolution 49/148 of 23 December 1994, entitled "Universal realization of the right of peoples to self-determination", the General Assembly requested the Commission on Human Rights to continue to give special attention to the violation of human rights, especially the right to self-determination, resulting from foreign military intervention, aggression or occupation.
- 7. The attention of the Commission on Human Rights is also drawn to General Assembly resolution 49/151 of 23 December 1994, entitled "Importance of the universal realization of the right of peoples to self-determination and of the speedy granting of independence to colonial countries and peoples for the effective guarantee and observance of human rights".

Special Rapporteur on the question of mercenaries

8. In its resolution 49/150, entitled "Use of mercenaries as a means to violate human rights and to impede the exercise of the right of peoples to self-determination", the General Assembly once again requested the Centre for Human Rights of the Secretariat, as matter of priority, to put more effort into publicizing the adverse effects of mercenary activities, to render advisory services to States that are experiencing the consequences of mercenary activities and to consider, within existing resources, working meetings to analyse and consider the political and legal aspects of the recommendations contained in the report of the Special Rapporteur, and requested the Special Rapporteur of the Commission on Human Rights to report with specific recommendations to the General Assembly at its fiftieth session on the new elements identified in the use of mercenaries.

- Item 10. Question of the human rights of all persons subjected to any form of detention or imprisonment
- Sub-item (b) Status of the Convention against Torture and Other Cruel,

 Inhuman or Degrading Treatment or Punishment
- 9. At its forty-ninth session, the General Assembly adopted resolution 49/177 of 23 December 1994 entitled "Report of the Committee against Torture and status of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment", in which it requested the Secretary-General to submit to the Commission on Human Rights at its fifty-first session and to the General Assembly at its fifty-first session a report on the status of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.

Sub-item (c) Question of enforced or involuntary disappearances

- 10. At its forty-ninth session, the General Assembly adopted resolution 49/193 of 23 December 1994 entitled "Question of enforced or involuntary disappearances", in which it called upon the Commission on Human Rights to continue to study this question as a matter of priority and to take any step it may deem necessary in pursuit of the task of the Working Group and to the follow-up of its recommendations when it considers the report to be submitted by the Working Group to the Commission at its fifty-first session. The General Assembly also invited the Commission at its fifty-first session to consider extending for three years the term of the mandate of the Working Group, as defined in Commission resolution 20 (XXXVI) of 20 February 1980, while maintaining the principle of annual reporting, and requested the Working Group to continue to fulfil its mandate in a rigorous and constructive fashion.
- Sub-item (d) Question of a draft optional protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment
- 11. At its forty-ninth session, the General Assembly adopted resolution 49/177 of 23 December 1994 entitled "Report of the Committee against Torture and Status of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment", in which it, inter alia, encourage the open-ended working group of the Commission on Human Rights on the elaboration of a draft optional protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment to intensify its deliberations with a view to an early conclusion of its work.

- Item 11. Further promotion and encouragement of human rights and fundamental freedoms, including the question of the programme and methods of work of the Commission
- Sub-item (a) Alternative approaches and ways and means within the
 United Nations system for improving the effective enjoyment
 of human rights and fundamental freedoms
- 12. In its resolution 49/186 of 23 December 1994, entitled "Alternative approaches and ways and means within the United Nations system for improving the effective enjoyment of human rights and fundamental freedoms", the General Assembly reiterated its request that the Commission on Human Rights should continue its current work on overall analysis with a view to further promoting and strengthening human rights and fundamental freedoms, including the question of the programme and working methods of the Commission, and on the overall analysis of the alternative approaches and ways and means for improving the effective enjoyment of human rights and fundamental freedoms in accordance with the provisions and ideas set forth in General Assembly resolution 32/130. In the same resolution, the Assembly urged all States to cooperate with the Commission on Human Rights in the promotion and protection of human rights and fundamental freedoms.

Non-selectivity, impartiality and objectivity

13. In its resolution 49/181 of 23 December 1994, entitled "Strengthening of United Nations action in the field of human rights through the promotion of international cooperation and the importance of non-selectivity, impartiality and objectivity", the General Assembly invited the Commission on Human Rights to continue to examine ways and means to strengthen United Nations action in that regard on the basis of resolution 49/181 and of Commission resolution 1993/59.

Rights of women

- 14. In its resolution 49/162 of 23 December 1994, entitled "Integration of older women in development", the General Assembly invited the competent organs of the United Nations to adopt an approach that, in all their strategies and programmes for the advancement of women, takes into account all stages of life.
- 15. In its resolution 49/165 of 23 December 1994, entitled "Violence against women migrant workers", the General Assembly called upon, among others, competent bodies and specialized agencies of the United Nations system to inform the Secretary-General of the extent of the problem and to recommend further measures to implement the purposes of the resolution. The General Assembly also invited the Special Rapporteur of the Commission on Human Rights on violence against women to continue to include among the urgent issues pertaining to her mandate the violence perpetrated against women migrant workers. The General Assembly also requested the Secretary-General to report at its fiftieth session on the implementation of resolution 49/165, including, in particular, on the report of the Special Rapporteur on violence against women.

- 16. In its resolution 49/166, entitled "Traffic in women and girls", the General Assembly drew the attention of the Special Rapporteur on violence against women and the Working Group on Contemporary Forms of Slavery of the Sub-Commission on Prevention of Discrimination and Protection of Minorities to the problem of trafficking in women and girl children.
- 17. The attention of the Commission is also drawn to the following General Assembly resolutions, all of 23 December 1994: 49/163, entitled "International Research and Training Institute for the Advancement of Women"; 49/167, entitled "Improvement of the status of women in the Secretariat"; 49/161, entitled "Implementation of the Nairobi Forward-looking strategies for the Advancement of Women"; 49/160, entitled "Proposed merger of the International Research and Training Institute for the Advancement of Women and the United Nations Development Fund for Women"; 49/164, entitled "Convention on the Elimination of All Forms of Discrimination Against Women".

Education and human rights

- 18. In its resolution 49/184 of 23 December 1994, entitled "United Nations Decade for Human Rights Education", the General Assembly requested the Centre for Human Rights and the Commission on Human Rights, in cooperation with Member States, human rights treaty-monitoring bodies, other appropriate bodies and competent non-governmental organizations, to support efforts of the United Nations High Commissioner for Human Rights to coordinate the Plan of Action for the Decade 1995-2005, as contained in the report of the Secretary-General (A/49/261/Add.1/Annex).
- 19. In the same resolution, the General Assembly requested the Secretary-General to consider the establishment of a voluntary fund for human rights education, with special provision for the support of the human rights education activities of non-governmental organizations, to be administered by the Centre for Human Rights.

Human rights and terrorism

20. The attention of the Commission is drawn to General Assembly resolution 49/185 of 23 December 1994, entitled "Human rights and terrorism".

National sovereignty and non-interference

21. In its resolution 49/180 of 23 December 1994, entitled "Respect for the principles of national sovereignty and non-interference in the internal affairs of States in their electoral processes", the General Assembly called upon the Commission on Human Rights at its fifty-first session to continue giving priority to the review of the fundamental factors that negatively affect the observance of the principles of national sovereignty and non-interference in the internal affairs of States in their electoral processes and to report to the General Assembly at its fiftieth session, through the Economic and Social Council.

United Nations Year for Tolerance

22. The attention of the Commission is drawn to General Assembly resolution 49/213 of 23 December 1994, entitled "United Nations Year for Tolerance".

Rule of law

- 23. At its forty-ninth session, the General Assembly adopted resolution 49/194 of 23 December 1994, entitled "Strengthening of the rule of law".
- 24. The attention of the Commission is also drawn to Commission resolution 1994/50 entitled "Strengthening of the rule of law", in which it decided to continue its consideration of this question at its fifty-first session.
- Sub-item (c) Coordinating role of the Centre for Human Rights within the
 United Nations bodies and machinery dealing with the
 promotion and protection of human rights
- 25. In its resolution 49/195 of 23 December 1994, entitled "Strengthening of the Centre for Human Rights of the Secretariat", the General Assembly requested the Secretary-General to submit an interim report to the Commission on Human Rights at its fifty-first session and a final report to the General Assembly at its fiftieth session on the strengthening of the Centre for Human Rights and on the measures taken to implement the resolution.
- Item 12. Question of violations of human rights and fundamental freedoms in any part of the world, with particular reference to colonial and other dependent countries and territories

Situation of human rights in various countries

- (a) Situation of human rights in the Islamic Republic of Iran
- 26. In its resolution 49/202 of 23 December 1994, entitled "Situation of human rights in the Islamic Republic of Iran", the General Assembly regretted that the Government of the Islamic Republic of Iran had still not permitted the Special Representative of the Commission to visit the country in order to enable him fully to discharge his mandate by according him full cooperation, and endorsed the view of the Special Representative that the international monitoring of the human rights situation in the Islamic Republic of Iran should be continued.
- (c) Situation of human rights in Afghanistan
- 27. In its resolution 49/207 of 23 December 1994, entitled "Situation of human rights in Afghanistan", the General Assembly, taking note with appreciation of the report of the Special Rapporteur on the situation of human rights in Afghanistan (A/49/650, annex) and of the conclusions and recommendations contained therein, recommended the translation of the report into the dari and pashtu languages.

28. Furthermore, the General Assembly urged the authorities in Afghanistan to continue to extend their full cooperation to the Commission on Human Rights and its Special Rapporteur. The General Assembly also decided to keep under consideration at its fiftieth session the situation of human rights in Afghanistan, in the light of additional elements provided by the Commission and the Economic and Social Council.

(d) Situation of human rights in Myanmar

29. The attention of the Commission is drawn to General Assembly resolution 49/197 of 23 December 1994, entitled "Situation of human rights in Myanmar".

(e) Situation of human rights in Cuba

30. The attention of the Commission is drawn to resolution 49/200 of 23 December 1994, entitled "Situation of human rights in Cuba", in which the General Assembly commended the Special Rapporteur of the Commission for his interim report on the situation of human rights in Cuba (A/49/544, annex).

(f) Situation of human rights in the territory of the former Yugoslavia

- 31. In its resolution 49/205 of 23 December 1994, entitled "Rape and abuse of women in the areas of armed conflict in the former Yugoslavia", the General Assembly invited the Commission on Human Rights to request the Special Rapporteur on the situation of human rights in the territory of the former Yugoslavia to continue to pay particular attention to the widespread occurrence of rape, particularly in Bosnia and Herzegovina, and acknowledged the work done by his team of female experts.
- 32. The General Assembly also requested the Secretary-General to submit an updated and substantive report no later than 1 March 1995 on the issue of rape and abuse of women in the areas of armed conflict in the Republic of Bosnia and Herzegovina, in particular in those areas where access is being denied to the Special Rapporteur, and on the measures taken for the implementation of its resolution 49/205.
- 33. In its resolution 49/196 of 23 December 1994, entitled "Situation of human rights in the territory of the former Yugoslavia: violations of human rights in the Republic of Bosnia and Herzegovina, the Republic of Croatia and the Federal Republic of Yugoslavia (Serbia and Montenegro)", the General Assembly commended the Special Rapporteur of the Commission on Human Rights for his reports (S/26383, S/26415, S/26463 and A/49/641-S/1994/1252, annex), and noted that his presence could be a positive factor towards reducing the instances of violations of human rights in the region. In the same resolution the General Assembly invited the Commission on Human Rights at its fifty-first session to request the Special Rapporteur to report to the General Assembly at its fiftieth session.

(g) Situation of human rights in Iraq

34. In its resolution 49/203 of 23 December 1994, entitled "Situation of human rights in Iraq", the General Assembly decided to continue its consideration of the situation of human rights in Iraq during its fiftieth session under the item entitled "Human rights questions" in the light of additional elements provided by the Commission on Human Rights and the Economic and Social Council.

(h) Situation of human rights in Haiti

35. In its resolution 49/201 of 23 December 1994, entitled "Situation of human rights in Haiti", the General Assembly decided to consider the situation further at its fiftieth session in the light of the information supplied by the Commission on Human Rights and the Economic and Social Council.

(i) Situation of human rights in the Sudan

36. In its resolution 49/198 of 23 December 1994, entitled "Situation of human rights in the Sudan", the General Assembly expressed its thanks to the Special Rapporteur for his most recent report (A/49/539) and welcomed the decision of the Commission on Human Rights to extend his mandate for an additional year.

(j) Situation of human rights in Rwanda

37. At its forty-ninth session, the General Assembly adopted resolution 49/206 of 23 December 1994, entitled "Situation of human rights in Rwanda", in which it welcomed the reports of the Special Rapporteur (E/CN.4/1995/7, E/CN.4/1995/12). The Assembly also welcomed the establishment, pursuant to Security Council resolution 955 (1994), of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January 1994 and 31 December 1994, and urged States to cooperate fully with the International Tribunal.

(k) <u>Situation of human rights in Kosovo</u>

38. At its forty-ninth session, the General Assembly adopted resolution 49/204 of 23 December 1994, entitled "Situation of human rights in Kosovo".

(1) Extrajudicial, summary or arbitrary executions

39. At its forty-ninth session, the General Assembly adopted resolution 49/191 of 23 December 1994, entitled "Extrajudicial, summary or arbitrary executions" in which it recommended that the Commission at its fifty-first session continue the mandate of the Special Rapporteur. The

Assembly also requested the Commission at its fifty-first session, on the basis of the report of the Special Rapporteur, to make recommendations concerning appropriate action to combat and eventually eliminate the abhorrent practice of extrajudicial, summary or arbitrary executions.

Item 13. <u>Measures to improve the situation and ensure the human rights and dignity of all migrant workers</u>

40. At its forty-ninth session, the General Assembly adopted resolution 49/175 of 23 December 1994, entitled "International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families".

Item 16. <u>Implementation of the Programme of Action for the Third Decade to Combat Racism and Racial Discrimination</u>

41. At its forty-ninth session, the General Assembly adopted resolution 49/146 of 23 December 1994, entitled "Third Decade to Combat Racism and Racial Discrimination". In this resolution, the General Assembly called upon Governments to cooperate more closely with the Special Rapporteur of the Commission on Human Rights on contemporary forms of racism, racial discrimination, xenophobia and related intolerance to enable him to fulfil his mandate. The General Assembly further requested the Secretary-General to submit each year to the Economic and Social Council a detailed report on all activities of United Nations bodies and the specialized agencies, containing an analysis of information received on such activities to combat racism and racial discrimination.

Item 18. <u>Effective functioning of bodies established pursuant to</u> United Nations human rights instruments

- 42. At its forty-ninth session, the General Assembly adopted resolution 49/145 of 23 December 1994, entitled "Report of the Committee on the Elimination of Racial Discrimination", in which it expressed its profound concern at the fact that a number of States parties to the International Convention on the Elimination of All Forms of Racial Discrimination still had not fulfilled their financial obligations, and requested the Secretary-General to continue to ensure adequate financial arrangements and appropriate means to enable the functioning of the Committee and to invite those States parties which were in arrears to pay the amounts in arrears.
- 43. The General Assembly also adopted resolution 49/178 of 23 December 1994, entitled "Effective implementation of international instruments on human rights, including reporting obligations under international instruments on human rights", in which it welcomed the submission of the report of the persons chairing the human rights treaty bodies of their 5th meeting, held at Geneva from 19 to 23 September, and took note of its conclusions and recommendations (A/49/537, annex, chap. IV). The General Assembly also welcomed the emphasis placed by the meeting of persons chairing the human rights treaty bodies and by the Commission on Human Rights on the importance of advisory services and technical assistance and, further to that end, requested the High Commissioner for Human Rights to report regularly to the Commission on possible technical assistance projects identified by the treaty

bodies. It also endorsed the recommendations of the meeting of persons chairing the human rights treaty bodies on the need to ensure financing and adequate staffing resources for the operations of the treaty bodies and, with that in mind, requested the Secretary-General to report on the question to the Commission on Human Rights at its fifty-first session. The Commission will have before it the report of the Secretary-General on this question (E/CN.4/1995/82).

Item 19. Report of the Sub-Commission on Prevention of Discrimination and Protection of Minorities on its forty-fifth session

At its forty-ninth session, the General Assembly adopted resolution 49/214 of 23 December 1994 entitled "International Decade of the World's Indigenous People". In its resolution the Assembly encouraged the Commission on Human Rights to consider the draft United Nations declaration on the rights of indigenous peoples, contained in the annex to resolution 1994/45 of 26 August 1994, of the Subcommission on Prevention of Discrimination and Protection of Minorities, with the participation of representatives of indigenous people, on the basis of and in accordance with appropriate procedures to be determined by the Commission, with a view to achieving the adoption of a draft declaration by the General Assembly within the Decade. Furthermore, the Assembly recognized the importance of considering the establishment of a permanent forum for indigenous people within the United Nations during the Decade, as recommended in the Vienna Declaration and Programme of Action, adopted by the World Conference on Human Rights, held at Vienna from 14 to 25 June 1993, and requested the Commission on Human Rights to make recommendations in this regard.

Item 20. Rights of persons belonging to national, ethnic, religious and linguistic minorities

45. At its forty-ninth session, the General Assembly adopted resolution 49/192 of 23 December 1994, entitled "Effective Promotion of the Declaration on the Rights of Persons Belonging to National or Ethnic, Religious and Linguistic Minorities" in which it called upon the Commission on Human Rights to examine ways and means to promote and protect effectively the rights of persons belonging to minorities as set out in the Declaration. It also called upon the Secretary-General to provide through the Centre for Human Rights, at the request of Governments concerned and as part of the programme of advisory services and technical assistance of the Centre, qualified expertise on minority issues and human rights, as well as on the prevention and resolution of disputes, to assist in existing or potential situations involving minorities.

Item 21. Advisory services in the field of human rights

Situation of human rights in Cambodia

46. In its resolution 49/199 of 23 December 1994, entitled "Situation of human rights in Cambodia", the General Assembly took note with appreciation of the report of the Special Representative of the Secretary-General (A/49/635 and Add.1) and endorsed his recommendations and conclusions. The General Assembly also noted with appreciation the use by the Secretary-General

of the United Nations Trust Fund for the Human Rights Education Programme in Cambodia to finance the programme of activities for the office of the Centre for Human Rights in Cambodia as defined in resolutions of the General Assembly and the Commission on Human Rights.

Item 24. Rights of the child, including:

Sub-item (a) Status of the Convention on the Rights of the Child

47. At its forty-ninth session, the General Assembly adopted resolution 49/211 entitled "Implementation of the Convention on the Rights of the Child".

Sub-item (b) Report of the Special Rapporteur on the sale of children

- 48. At its forty-ninth session, the General Assembly adopted resolution 49/212 of 23 December 1994, entitled "Plight of street children", in which it called upon special rapporteurs, special representatives and working groups of the Commission on Human Rights and the Sub-Commission on Prevention of Discrimination and Protection of Minorities, within their mandates, to pay particular attention to the plight of street children.
- 49. The General Assembly also adopted resolution 49/210 of 23 December 1994, entitled "Need to adopt efficient international measures for the prevention of the sale of children, child prostitution and child pornography". In the resolution, the Assembly welcomed the provisional report (A/49/478, annex) of the Special Rapporteur on the sale of children, child prostitution and child pornography. The Assembly also noted the establishment by the Economic and Social Council in its resolution 1994/9 of an open-ended working group responsible for elaborating as a matter of priority, guidelines, in close contact with the Special Rapporteur, of a possible draft convention on the issue related to the sale of children, child prostitution and child pornography, as well as the basic measures required for preventing and eradicating these serious problems. It also invited the Special Rapporteur, within the framework of his mandate to continue providing attention to the economic, social, legal and cultural factors affecting these phenomena.
- 50. The General Assembly also adopted resolution 49/209 of 23 December 1994, entitled "Protection of children affected by armed conflict", in which it expressed grave concern about the tragic situation of children in many parts of the world as a result of armed conflicts, and requested bodies and organizations of the United Nations, as well as intergovernmental and non-governmental organizations, within the scope of their respective mandates, to cooperate in order to ensure more effective action in addressing the problem of children affected by armed conflicts. The Assembly welcomed the appointment of an expert, working in collaboration with the Centre for Human Rights and the United Nations Children's Fund, to undertake a comprehensive study of this question, and took note of the progress report of the Secretary-General on the work of the above-mentioned expert (A/49/643). The Assembly also invited the Commission on Human Rights to consider the study at its fifty-first session.

Item 25. Follow-up to the World Conference on Human Rights

51. At its forty-ninth session the General Assembly adopted resolution 49/208 entitled "Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action" in which, <u>inter alia</u>, it requested the Secretary-General, the General Assembly, the Commission on Human Rights and other organs and bodies of the United Nations system related to human rights to take further action with a view to the full implementation of all the recommendations of the Conference.
